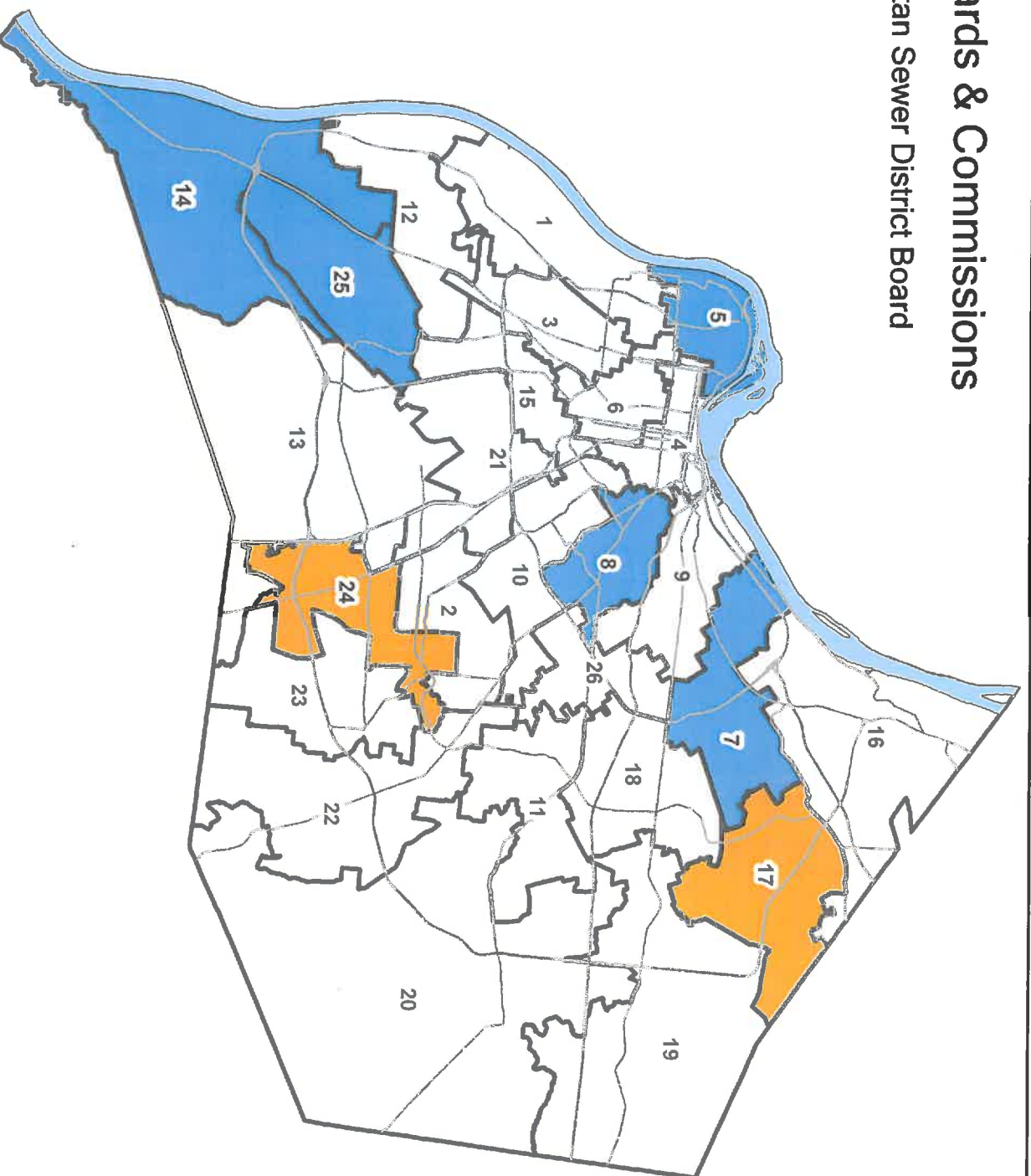

HOW APPOINTED	Mayor appoints 8.
EX OFFICIO MEMBERS	None
QUALIFICATION OF MEMBERS	No more than 5 members shall be affiliated with the same political party. No more than 1 can reside in any one senatorial district. Must be 25 years of age or older. Must be residents of County for at least 3 years prior to appointment. No officer or employee of Metro government is eligible for appointment.
COUNCIL APPROVAL OF APPOINTMENT	Yes
COMPENSATION	\$75 for each board meeting attended and \$50 for each committee meeting attended, but no more than \$1800 during any fiscal year nor for more than 24 board meetings and 28 committee meetings.
TERM OF APPOINTMENT	3 years terms and until their successors are appointed and qualified.
VACANCY APPOINTMENT	Vacancies in the membership shall be filled for the unexpired portion of the term by the mayor or the county judge/executive as the case may be, subject to the same approval.
AUTOMATIC REAPPOINTMENT UNDER KRS 65.008(2)?	Yes
REMOVAL	For cause
POWERS	The sewer district through its board, is empowered to have jurisdiction, control, possession and supervision of the existing sewer and drainage system; to maintain, operate, reconstruct, and improve the system; to acquire and hold or dispose personal and real property; to sue and be sued; to contract and contracted with; to borrow money and issue negotiable bonds; to fix and collect sewer rates, rentals and other charges; to prepare or cause to be prepared and thereafter revise or adopt plans, designs, and estimates of costs pertaining to the existing and future sewer and drainage

	system; make rules and regulations.
BONDING AUTHORITY	Yes
RECORDS/ REPORTS	The board shall make and spread upon its records adequate descriptions, by map or otherwise, of the district area. To prepare or cause to be prepared and to be thereafter revised and adopted, plans, designs, and estimates of costs, of a system of trunk, intercepting, connecting, lateral, and outlet sewers, storm water drains, pumping and ventilating stations, disposal and treatment plants and works. Establish a schedule of rates, rentals, and charges, to be collected from all the real property.
PURPOSE	Manage, control and conduct business activities and affairs of joint metropolitan sewer district to provide adequate sewer and drainage facilities to the public.
MEETING	At least once each calendar month.

QUORUM	A majority of the members of the board shall constitute a quorum, and the affirmative vote of at least three (3) members of the board shall be necessary for the adoption of any motion, measure, or resolution.
