

ITEMS FOR COUNCIL CONSIDERATION

- Page 1 1.01d
 - Addresses amendments to the Rules of the Council
 - **Suggestion is that the ENTIRE Council must vote in the affirmative to adopt the Rules.**
- Page 1 1.02 Term Lengths and Elections
 - Defines sitting term limit for the Council AS A WHOLE
 - Amending 7.03 to have a time limit such as one calendar year, etc. accomplishes the same intent
- Page 12 4.03d
 - **Allows Council Members to make motions and seconds on zoning items within their district regardless of their being on the PZA Committee**
- Page 17 4A.04b2
 - Subpoenas issued by the GOA Committee
 - Currently a majority vote of the Committee members present is needed meaning if 7 are present, a vote of 4 could approve it; **the suggestion is to be the ENTIRE Committee**
- Page 20 5.07
 - **Adds definitions per Robert's Rules and a Westlaw article**
- Page 22 5.12
 - Suspending rule regarding the deadline to submit ordinances and resolutions to the Clerk's Office; current rule, which is not followed, states that it can only be suspended if presented in writing and signed by all Council Members in attendance. **The suggestion is to remove it OR add it to Rule 6.02 if the Council wishes to follow it**
 - Second consideration: If the Council means to make the motion to commit or reconsider undebatable (which is NOT in agreement with Robert's Rules), then language in 5.11 needs to be added
- Page 26 6.06a
 - Gives the President the authority to approve adding items to the final Council agenda
 - **The suggestion is to remove this language**
- Page 28 7.01b
 - Addresses how many readings a Resolution needs to be passed
 - **Suggestion is to add Resolutions in with Ordinances which requires two readings, except in the case of an emergency or an admin/function of the Council**
- Page 30 7.05e
 - Addresses items that pass unanimously from committee being moved from Consent Calendar to Old Business

- **Suggestion is to add “without any votes against, without any abstentions and/or did not have any amendments made”. (NEW LANGUAGE: At a regular or special Council meeting, the presiding officer of a committee may request that an item which had come from committee without any votes against, without any abstentions and/or did not have any amendments made be moved from Old Business to the Consent Calendar if there is no objection.)**
- Page 38 10.05
 - Deals with Council Members status during an appeal of removal from office
 - **Suggestion is to remove the language altogether which states that any Council Member appealing removal may not sit on the Council or any of its committee meetings, but that the office is not vacant until all appeal rights have been exhausted. KRS GOVERNING REMOVALS DOES NOT CONTAIN THIS LANGUAGE AND SO SUGGESTION IS TO REMOVE IT**
- Page 38 10.06
 - Deals with the removal of President
 - **Suggestion is to remove the word and all references to “court”. Acting as a court would mean that the President, the Council court and the charging Council Member would ALL need attorneys and the removal would need to work like an actual court**
 - **Suggestion is to state that 12 Council Members may initiate removal on the basis of inability of the President to carry out the duties of the Office. President may be removed with an affirmative vote of 20 Council Members**
