I will be asking that item 8 on the June 20th agenda for Decorative trash cans in District 5 be amended on Wednesday from a total of \$11,464 to \$19,238 District 5 CIF for these three historic neighborhoods.

The amended changes will reflect a total increase for Portland from 14 to 17 decorative cans; for Shawnee from 3 to 11 decorative trash cans, and adding 3 cans for the historic Russell neighborhoods. The number of additional liners will remain unchanged.

The sites for the cans have been submitted to and approved by Public Works and will be submitted to the Clerk prior to the meeting for the record.
