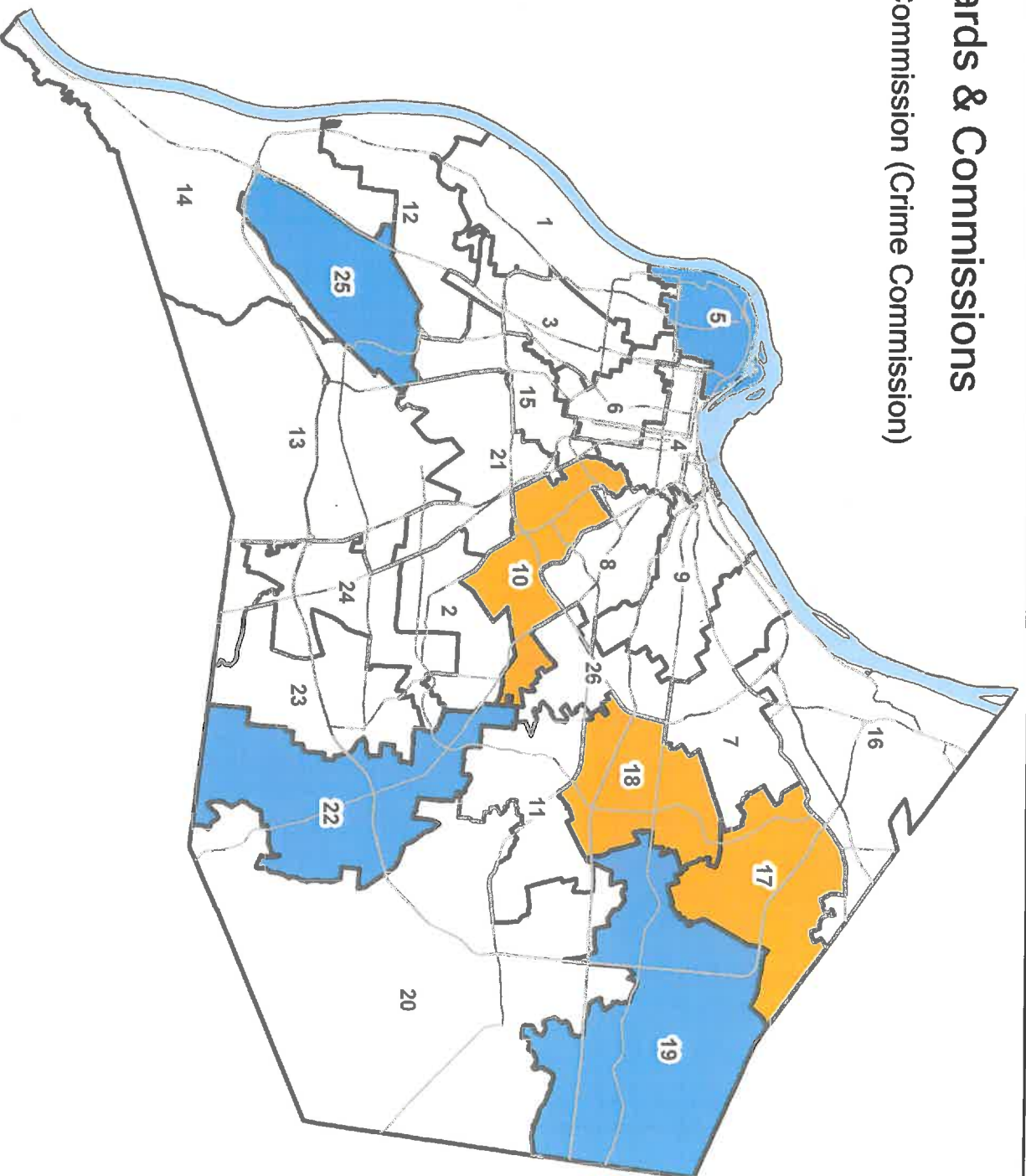

HOW APPOINTED	<p>The Mayor shall appoint 6 citizen members to the Commission, subject to the approval of the Metro Council. The citizen membership shall include three members representing the community at large and three members representing disciplines and/or constituency groups impacted by criminal justice operations, including but not limited to providers or organizations addressing substance abuse treatment, homelessness, and victim advocacy.</p> <p>The following serve by virtue of office or position or their designative representative:</p> <p>Mayor of Louisville/Jefferson County Metro Government</p> <p>Chief, Louisville Metro Police Department</p> <p>Director, Louisville Metro Corrections Department</p> <p>Chief Judge, Jefferson Circuit Court</p> <p>Chief Judge, Jefferson District Court</p> <p>Chief Judge, Jefferson Family Court</p> <p>Jefferson County Commonwealth's Attorney</p> <p>Jefferson County Attorney</p> <p>Director, Kentucky Probation and Parole</p> <p>Director, Office of Pre-Trial Services for Jefferson County</p> <p>Chief Public Defender/Executive Director, Louisville/ Jefferson County Public Defender Corporation</p>

MEETING	The Commission shall meet as often as it deems necessary, but it shall not meet less than six times each year. All meetings shall be open to the public.
