IDEAFESTIVAL SUMMARY OF \$25,000 REQUEST FROM METRO COUNCIL

August 2, 2017

IdeaFestival is requesting up to \$25,000 from members of Metro Council to be treated as an inter-agency transfer from Neighborhood Development Funds to Economic Development.

IdeaFestival respectfully requests from Louisville Metro Council's Neighborhood Development Funds up to \$25,000 in support of IdeaFestival's annual Fall event to be held September 26 – 28, 2017 at the Kentucky Center for the Performing Arts.

The mission of IdeaFestival is to design and provide a platform through live events to promote the discussion and application of innovation, curiosity, discovery and disruptive thinking. It seeks to inspire and empower individuals, businesses, organizations and communities to grow, innovate and stay relevant in the 21st century.

IdeaFestival programming is making a great impact by transforming the image of Louisville, raising the city's awareness nationally and globally as an innovative and entrepreneurial hub.

In 2016, nearly 6.5 million print and online subscribers were introduced to IdeaFestival and Louisville via national media brands like *Inc.*, *TechRepublic* and *ZDNet*, along with regional and local coverage. At the local and regional level IdeaFestival benefited from strong partnerships with WFPL, *Business First*, *Insider Louisville* and KET among others, sharing our speakers with an even broader audience than the Kentucky Center could accommodate.
