The following was discussed:

- March 25th is Equal Pay Day when a woman's pay catches up to a man's pay from 2019
- Reference to the Parental Leave Ordinance currently being considered by the Council
- Gender Pay Gap being an univariable analysis
- Possible childcare crisis coming due to day cares closing during the pandemic
- Whether there are any local governments that have been able to enforce pay equity possible legislation coming from the Federal government in the future that will impact private businesses due to President Joe Biden's interest in the topic
- Promoting the study of the sciences and STEM programs to girls
- Example of the differences in the workplace due to women having to take time off for child birth and how it puts the women behind men when it comes to retirement
- Understanding that pay equity is about equal pay for equal work

Adjournment

Chair McCraney spoke about an upcoming topic for the April 15, 2021 Committee meeting regarding equity in job descriptions. She stated that the Administration was conducting a pay equity study for Metro Government and a report may be available as early as June. She also spoke about a Resolution that will be introduced soon that encourages the private sector to conduct pay equity analyses.
