HIS MOM HAD SEVERAL KIDS AND SHE HAD SUBSTANCE ABUSE PROBLEMS AND MADE IT IMPOSSIBLE FOR HER TO CARE FOR HER KIDS.

LEARNING A WORK ETHIC AND BOYS AND GIRLS THAT HELPED HIM, HE DOESN'T GIVE UP.
