AN ORDINANCE APPROPRIATING ~~\$43,200~~ ~~\$59,200~~ \$60,200 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$6,400 EACH FROM DISTRICTS 23, 5 7; ~~\$8,000~~ \$11,200 FROM DISTRICT 12; \$9,600 FROM DISTRICT 7; \$4,800 EACH FROM DISTRICTS 3, 10, 11; \$3,200 EACH FROM DISTRICTS 17, 21; \$1,600 EACH FROM DISTRICTS 4, 8, 9; \$1,000 FROM DISTRICT 6; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO COMMONWEALTH THEATRE CENTER, INC., FOR PROGRAMMING EXPENSES ASSOCIATED WITH PERFORMANCES OF "THE BOY WHO CRIED WOLF." (AS AMENDED)

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:


SECTION I: The sum of ~~\$43,200~~ ~~\$59,200~~ \$60,200 is appropriated from Neighborhood Development Funds in the following manner: \$6,400 each from Districts 23, 57; ~~\$8,000~~\$11,200 from District 12; \$9,600 from District 7; \$4,800 each from Districts 3, 10, 11; \$3,200 each from Districts 17, 21; \$1,600 each from Districts 4, 8, 9; \$1,000 from District 6; through the Office of Management and Budget, to Commonwealth Theatre Center, Inc., for programming expenses associated with performances of "The Boy Who Cried Wolf."

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
