AN ORDINANCE APPROPRIATING \$12,000 \$12,500 \$18,000 FROM DISTRICT NEIGHBORHOOD DEVELOPMENT FUNDS AS FOLLOWS: \$5,000 FROM DISTRICT 9 AND \$1,000 EACH FROM DISTRICTS 1, 5, 8, 13, 16, 17, 2, AND 22, ; AND \$500 EACH FROM DISTRICTS 21, 3, 4, 6, 10, 12, 14, 15, 24, AND 25, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE GIRL SCOUTS OF KENTUCKIANA, INC. FOR NEEDS BASED MEMBERSHIP ASSISTANCE. As Amended

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$12,000 \$12,500 \$18,000 is hereby appropriated from the District Neighborhood Development Funds as follows: \$5,000 from District 9; \$1,000 each from Districts 1, 5, 8, 13, 16, 17, 2, and 22, ; and \$500 each from Districts 21, 3, 4, 6, 10, 12, 14, 15, 24, and 25, through the Office of Management and Budget, to the Girl Scouts of Kentuckiana, Inc., for needs based membership assistance.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures, Section 3, as adopted by Resolution No. 290, Series 2011.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
