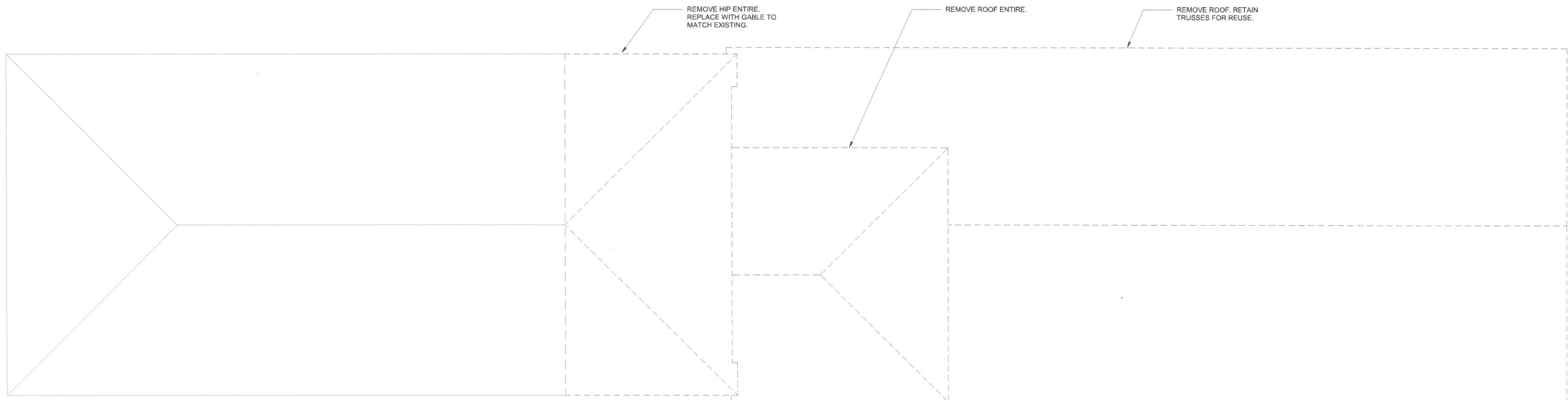


1 THIRD FLOOR DEMOLITION PLAN
