Subj.: ***"Requests to County Sheriff to Remove Judges"*** - Page 1 of 2 -

Hello, I am Daniel Cobble. Please enter this my written statement with attached four documents, that you have, into the Council's record.

These attachments include the three notarized *Requests for Removal* to Sheriff John Aubrey, for removing Judge Charles L. Cunningham, Jr. and Judge Barry Willett of the Jefferson County Circuit Court from their duties and public office. These judges are in violation of their **oaths-of-office** to the U.S. and Kentucky Constitutions, by refusing to process cases that are filed with the Jefferson County Court Clerk.

In case 10-CI-8625 where I paid a \$153 filing fee, Judge Cunningham is refusing to process / ratify undisputed Lien 2008-2298237-43.01. The Debtor has not appeared in Cunningham's court to factually challenge or provide evidence against this lien.

In case 12-CI-584, where Carolyn Jones paid a \$153 filing fee, Judge Cunningham is refusing to process Ms. Jones' dental accident claim. Ms. Jones has met Judge Cunningham's requirement for an Amended *Complaint*, but Cunningham refuses to process that Complaint.


In case 11-CI-5650, where I paid a \$153 filing fee, Judge Willett is refusing to process / ratify undisputed Liens 2011-2516531-27.01 and 2011-2516533-49.01. The Debtors have not appeared in Willett's court to factually challenge or provide evidence against these liens.

If Sheriff Aubrey refuses to remove these judges, then he, too, is in violation of his **oath-of-office** to uphold Our constitutions.

In addition, please see attached the first-page of my September 29, 2014 administrative Tort Claim, **COB-2014-0844** filed against this Metro

Government and the Kentucky Court of Justice, for refusing to allow me into the courtrooms of Jefferson County, and the harassment that I be escorted by the Sheriff Department whenever I am allowed into the court clerk's office. Chief Judge Audra Eckerle began preventing me from entering her courtroom on **February 13, 2012**. Up to **September 22, 2014**, this year, I was again denied entry to the courthouse when attempting to enter Judge Cunningham's courtroom.

With this continuing harassment entering 3 years, I was forced to file this Tort Claim. You may see the complete claim with evidence at www.the-louisville-underground.org – *Thank you!*

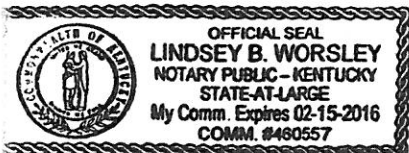


Dear Sheriff Aubrey,


Pursuant to your duties as the Jefferson County Sheriff, **please remove Judge Charles L. Cunningham, Jr.** from his duties / office for **"violating his oath of office"** by refusing to process a medical accident claim.

Without cause, Judge Cunningham refuses to require Defendants to Answer the **Sept. 23, 2013** [Amended] Complaint of Carolyn Jones, Case 12-CI-0584. Jones requested the processing of her accident claim on **Jan. 31, 2012**. Cunningham's **March 26, 2012** Order instructed Jones to re-file her Complaint "in her best interest." However, Cunningham refuses to recognize and process Jones' subsequent 9-23-2013 Amended Complaint (*supra*) without stating a legal cause for refusing to process that Complaint. – And Cunningham is leaving Jones' physical / medical injuries untreated.

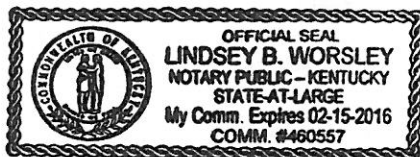
