The following was discussed:

- This amendment is to promote the installation and maintenance of managed natural landscapes
- The managed natural landscapes include native plants that benefit the city's environment
- Managed natural landscapes shall not include turf-grass lawns left unattended
- Questions and concerns about adding a certain width for the setback for deliveries

- The definition of "noxious weed" is an annual, biennial, or perennial plant to be injurious to public health, the environment, public roads, crops, livestock, or other property
- Managed natural landscape is planned, intentional, and maintained planting of native or non-native grasses
- Maintenance is defined as keeping the planting within the defined area, free of noxious weeds which are not allowed
- The managed landscape must be set back from property lines by at least five feet
- The managed landscape must be mowed or cut back at least once per year in addition to ongoing maintenance
- The area of plant growth must not extend into the public right-of-way
- Question about whether there is a list of native plants
- Training is being provided for Codes and Regulations Officers on what constitutes native plants
- Question about the process of a dispute on a citation
- Questions and concerns on how to handle complaints in dense areas

A motion was made by Committee Member Piagentini, seconded by Council Member Hollander, that this Ordinance be tabled.

The motion to table carried by a voice vote.
