The following was discussed:

- The changes being proposed are more in line with Vettiner and Seneca Golf Courses
- Reviews are that Quail Chase is not as good a course as others with fee structure
- Fee comparison of 9-hole vs. 18-hole vs. 27-hole
- 9-hole fees are not the same at Quail Chase, with it being a 27-hole course
- Clarification needs to be that other than Quail Chase fee, all other 9-hole course fees are for 18-holes
- Winter rates were not included in original
- There is a fee at Quail Chase that is charged for 9-hole play, but not in the record
- No other fee table needs to be created
- Cart rates vs. green fees

A motion was made by Committee Member Peden, seconded by Committee Member Fox, that the Ordinance be amended as follows:

- Add Quail Chase to LMCO Section 42.41(D)(2)(a) so that the title of that Section now reads as "(a) Seneca, Charlie Vettiner, and Quail Chase (18-hole) courses."
- LMCO Section 42.41(D)(2)(e) would include only the 9-hole rates already proposed in this Ordinance.

Committee Member Peden made a motion to Call the Question, but it failed for lack of a second.

The motion to amend carried by a voice vote.

Chair Person Fowler read the rates for the 9-hole course as stated in the Ordinance:

- Summer Weekend Rates, \$16.00
- Summer Weekday Rates, \$16.00
- Summer Junior Rates, \$16.00
- Winter Weekend Rates, \$15.00
- Winter Weekday Rates, \$15.00
- Winter Junior Rates, \$15.00
- Annual Pass Rate for Adults, \$7.50
- Annual Pass Rate for Juniors, 4.00
- Fees for Leagues 1, 2, 3, and Early will no longer be effective

Chair Person Fowler also stated that Derby, Specials, and Weekend Twilight fees were no longer effective and can be addressed with dynamic pricing.

A motion was made by Council Member Peden, seconded by Council Member Mulvihill, to accept the amended 9-hole rates. The motion carried by a voice vote.

The motion to recommend for approval carried by the following vote and the amended Ordinance was sent to Old Business:
