



Dear Gov. Bevin,

You campaigned as an “outsider candidate” promising to shake-up the Kentucky gov'mt to protect the rights of all Kentuckians. Yet, as shown below, Kentucky still operates “business as usual” in total corruption, confiscating our tax dollars while denying our Constitutional Rights. – Sir, you are not a “change agent,” but allowing this “tax-slavery” to go on.

On Nov. 18, 2016, when opening my family’s self-serve safe deposit box (Box #3917) at PgNC Bank, the box contents were re-arranged w/ \$2600 missing. We were burglarized. PNC Branch K60K442-01-1 at 3603 Old Bardstown Rd., Zip 40218. – Branch management denied PNC was involved (Head Mgr. Shannon Gullett & Assist. Debbie Day). But that cannot be true, since the old lock on the box was newly manufactured / replaced, and without our knowledge. The old keyed-lock was a very old, darkly tarnished indented lock that required jiggling our key to open it. But now our same key works perfectly; see attached photo. – Louisville Police Officer James R. Martin (Badge #7793) filed false Report #80-16-099043 calling the incident “PROPERTY LOST OR ABANDONED, NON CRIMINAL” with only me a the victim. But Mrs. Cobble is a VICTIM, too. – Photos of new lock given to Detective M. Braden (#7819, 502-574-6197), but Det. Braden won’t return our phone calls. – (Also, NO RESPONSE from Chief Robert Conrad on local complicity to mail fraud Complaint, Certified Item 7016 0750 0000 0369 1197, 502-574-7660.)

• 2nd safe deposit box burglary at PNC Bank that Louisville Police won’t investigate:

1. In approx. same week of Nov. 18, safe deposit box of PNC Customer Jan Beamer reported burglarized. 9700 Linn Station Rd., Branch K6-KB56-01-1,
2. Police has not investigated this burglary; Ms. Beamer reports property in box stolen.

Resolution: Gov. Bevin, please dispatch KY Banking Commission to: **1)** investigate these apparently inside-job burglaries at PNC Bank, **2)** report this matter to the F.B.I., Sec. Exch. Comm., Etc, **and 3)** review L.M.P.D.’s reluctance to investigate PNC & local complicity to mail fraud Complaint; or exempt my wife and me from paying taxes in Kentucky. – *Thank you!*
