FOR THE PAST THREE MONTHS NOT ONE METRO COUNCIL MEETING HAS GONE BY WHERE YOU HAVEN'T HEARD STORIES FROM THE VICTIMS OF LOUISVILLE'S AFFORDABLE HOUSING CRISIS.

SENIOR CITIZENS, CLERGY, 60,000 FAMILIES NEED SAFE AFFORDABLE HOMES.

PEOPLE IN EVERY COUNCIL DISTRICT AND EVERY PART OF TIME.

A FEW YEARS AGO MY HUSBAND AND I RETIRED, WE WERE RETIRED ONLY A SHORT PERIOD OF TIME BEFORE WE REALIZED WE WERE NOT GOING TO BE ABLE TO KEEP UP WITH OUR HOUSING COSTS ON FIXED INCOMES ONLY.

SO AT 66 WE WENT BACK INTO THE WORKFORCE AND HAVE BEEN WORKING EVER SINCE.

WE ARE CURRENTLY ABLE TO AFFORD WHERE WE LIVE HOWEVER IN THE BACK OF OUR MIND THERE'S ALWAYS THE FEAR AND THE QUESTION, WHAT IF ONE OF

US BECAME ILL, DISABLED, NO LONGER ABLE TO WORK? PUSHING THE COST OF OUR APARTMENT OUT OF OUR REACH.

THE AFFORDABLE HOUSING TRUST FUND -- PLACES THAT MY HUSBAND AND I COULD AFFORD TO LIVE AND BE RETIRED.

SUCH AS THE MIDDLETOWN APARTMENT A SHORT DRIVE DOWN THE STREET FROM WHERE I NOW LIVE.

EVERYONE, EVERYONE DESERVES SAFE, DECENT AFFORDABLE HOUSING.

WHICH IS WHY I'M HERE TONIGHT TO ASK EACH OF YOU, WILL YOU ADVOCATE FOR \$10 MILLION IN LOUISVILLE'S AFFORDABLE HOUSING TRUST FUND IN THE UPCOMING BUDGET.

- I WORK AT NORTON CHILDREN'S HOSPITAL AS A BAKER.
- I LOVE WHAT I DO AND I ENJOY WHERE I WORK.
- I MANAGED TO RAISE MY PAY FROM \$9 AN HOUR TO \$14.
- I HAVE BEEN LIVING WITH TWO WOMEN, I DID NOT PREVIOUSLY KNOW IN ORDER TO AFFORD MY HOUSING.
- I HAVE BEEN ABLE TO BUILDUP SOME SAVINGS BUT THAT HAS GONE TO PURCHASE THINGS LIKE A BED AND STUFF LIKE THAT, BASIC THINGS THAT MOST PEOPLE TAKE FOR GRANTED.

UNFORTUNATELY FOR US THOUGH, THE HOUSE WE HAVE BEEN RENTING HAS BEEN SOLD AND WE ARE TO BE PUT OUT ANY DAY NOW.

MYSELF AND MY ROOMMATES HAVE BEEN SEARCHING THE WHOLE CITY FOR A PLACE TO LIVE WHERE WE FEEL SAFE AND COMFORTABLE, AND OF COURSE A PLACE WE CAN AFFORD, AND SPLITTING RENT THREE WAYS WE HAVEN'T BEEN ABLE TO FOUND A SAFE AFFORDABLE PLACE TO WIN.

THE CLOCK IS RUNNING OUT, AND I'M LOOKING AT HAVING TO MOVE IN WITH MORE STRANGERS, WHICH I'M NOT COMFORTABLE FOR, BUT IT'S EITHER THAT OR LIVE IN MY CAR OR A HOTEL ROOM.

I KNOW I'M NOT ALONE IN THIS SITUATION, THERE ARE TOO MANY OTHERS.

I SEE THEM EVERYDAY ON THE STREETS, RIDING THE BUSSES TO KEEP WARM.

I'M BECOMING THE FACE OF THE HOMELESS AND I DON'T WANT TO BECOME A STATISTIC.

I ASK YOU TO INVEST \$10 MILLION IN THE AFFORDABLE HOUSING TRUST FUND SO SAFE AND AFFORDABLE PLACES COULD BE DEVELOPED FOR HARD WORKING PEOPLE LIKE MYSELF.

HALF OF AFRICAN AMERICAN AND LATINO CHILDREN BORN AFTER THE YEAR 2000 WILL DEVELOP DIABETES AND OTHER CHRONIC CONDITIONS.

COMMUNITIES OF COLOR ARE TARGETED.

THERE ARE TWICE AS MANY ADS.

WE SEE THEM EVERYWHERE.

IT'S RIDICULOUS.

MOST AT RISK FOR DIET-RELATED DISEASES ARE AFRICAN AMERICAN AND LATINO CHILDREN.

WE WOULD LIKE FOR THESE DRINKS TO BE TAKEN OFF KIDS MENUS AND PUT HEALTHY DRINKS FIRST, BECAUSE THAT'S WHAT KIDS SHOULD BE GIVEN AS AN OPTION.

HE WAS TEACHING MATH IN JEFFERSON COUNTY PUBLIC SCHOOLS, TWO YEARS AT MYERS, ONE YEAR AT SHAWNEE.

HE HAD A PLACE IN HIS HEART TO GIVE THEM THE FIRST CHANCE THEY NEEDED, BEFORE THEY NEEDED A SECOND ONE.

HE IS IN HIS THIRD YEAR, HE STARTED WITH 17 YOUTH.

IT QUICKLY JUMPED TO 44 AND THEN JUMPED TO 90 AND I BELIEVE HE WILL HAVE 120 YOUTH IN THE PROGRAM THIS SUMMER.

HE WILL BE EMBARRASSED AS I SHARE WITH YOU, HE IS COMPETING WITH 74 OTHER YOUNG MEN OF COLOR.

IT'S CALLED THE BE ME.

A BLACK MALE INITIATIVE THAT DARYL UNSELL BROUGHT TO OUR CITY AND THERE ARE ONLY SEVEN CITIES IN THE UNITED STATES OF AMERICA THAT HAVE THIS PROGRAM AND MR. FLEMING, WE HOPE WILL WIN A TICKET AND BE ONE OF 15 COMPETING FOR A \$15,000 GRANT FROM WASHINGTON D.C.

LADIES AND GENTLEMEN IN RECOGNITION OF NATIONAL YOUTH VIOLENCE PREVENTION WEEK, I WANT TO INTRODUCE DA' MARRION FLEMING AND LET HIM TELL HIS STORY ABOUT SOWING SEEDS OF FAITH.

DA' MARRION FLEMING: THANK YOU, COUNCILWOMAN.

DA' MARRION FLEMING.

I WAS BORN AND RAISED IN LOUISVILLE.

LOUISVILLE GRAD.

STARTED IN PROGRAM THREE YEARS AGO WITHOUT A 501C3.

JUST WANTED TO TUTOR KIDS.

I UNDERSTOOD THE ISSUE WASN'T BETWEEN 7:40 AND 2:20 BUT BETWEEN 2:20 AND 10:00 P.M. SO I TOOK THE INITIATIVE, STARTED A FOOD TRUCK COMPANY, THE FOOD TRUCK DID WELL AND STEPPED AWAY FROM THAT TO RUN MY NON-PROFIT FULLY.

WE STARTED WITH 44 KIDS.

AT THE END OF THE TUTORING PROGRAM, PARENTS WERE ASKING WHAT'S THE PLAN FOR THE SUMMER.

I SAID LET'S START A SUMMER PROGRAM.

SO I TOOK 64 KIDS AND DID AN ENRICHMENT THAT FOCUSED ON MATH, READING COMPREHENSION, READING LITERACY.

WE TOOK THE INITIATIVE TO RUN THE PROGRAM WITHOUT FUNDING AND WE WERE SUCCESSFUL WITH THOSE 64 KIDS.

WE CAME BACK WHEN I BECAME OFFICIAL 501(C)3 AND DOUBLED THE PROGRAM.

WITHIN ONE YEAR I WAS ABLE TO DOUBLE MY PROGRAM.

I DID IT THE SECOND YEAR ABSOLUTELY NO FUNDING.

I SPENT ABOUT THREE HOURS LEARNING WHAT BYLAWS WERE AND HOW TO WRITE MY OWN BYLAWS.

I WAS ABLE TO TEACH OUR YOUNG LADIES ABOUT BEING PROMINENT AND BEING SUCCESSFUL.

PRESIDENT JAMES: THE RESOLUTION IS BEFORE US, IS THERE ANY DISCUSSION? COUNCILMEMBER GREEN?

COUNCILMEMBER GREEN: THANK YOU, MR. PRESIDENT.

THIS RESOLUTION PASSED OUT OF COMMITTEE UNANIMOUSLY WITH BIPARTISAN SUPPORT.

I FILED THIS ASKING THE ATTORNEY GENERAL TO COME INTO OUR JURISDICTION BECAUSE THEY HAVE TO BE INVITED IN AND SO TO LOOK AT THE CASE, YOU MAY HAVE SEEN IT IN THE NEWS INVOLVING FORMER M.A. EDWIN CHANDLER WHO WAS WRONGFULLY CONVICTED.

DENNY BUTLER HAS WORKED TIRELESSLY ON THIS AND DEVOTED HOURS AND HOURS ON THIS AND WAS WORKING WITH THE PROJECT.

MR. CHANDLER WAS RELEASED AFTER ABOUT NINE YEARS.

THE CITY IS OUT MILLIONS AND THIS OFFICER WAS ACTUALLY INVOLVED IN SEVERAL OTHER INVESTIGATIONS WHERE PEOPLE SPENT DECADES IN PRISON AND WERE RELEASED.

WE SUPPORT OUR LAW ENFORCEMENT, WE LOVE OUR LAW ENFORCEMENT, BUT WE CALL OUT THE BAD ACTORS AND WE DEAL WITH THEM AND IF THERE ARE CRIMINAL CHARGES THAT NEED TO BE LEVIED, WE EXPECT THAT TO HAPPEN.

SO THIS ITEM IS ON OLD BUSINESS SO THAT COUNCILMEMBER BUTLER CAN ABSTAIN FOR THIS VOTE.

PRESIDENT JAMES: COUNCILMEMBER BUTLER?

COUNCILMEMBER BUTLER: THANK YOU.

DUE TO PERCEIVED CONFLICT, SINCE MY BROTHER WAS INVOLVED WITH THE INNOCENCE PROJECT ON THIS PARTICULAR CASE, I NEED TO ABSTAIN.

PRESIDENT JAMES: YES, MA'AM.

COUNCILMEMBER WOOLRIDGE?

>> THANK YOU, MR. PRESIDENT.

I HAVE SPOKEN TO THE SPONSOR OF THIS RESOLUTION AND I HAVE ASKED TO SIGN ON AND SHE HAS AGREED IT WOULD BE OKAY.

I WANT TO DITTO EVERYTHING SHE HAS SAID.

WE SUPPORT OUR POLICE OFFICERS BUT WE DON'T WANT ANY BAD APPLES BECAUSE THE BAD APPLES WILL SPOIL THE ENTIRE BUNCH.

I WAS SO IMPRESSED WITH DENNY BUTLER'S TESTIMONY.

HE WAS JUST ABSOLUTELY SO THOROUGH.

WE KNOW WE PAID OUT MILLIONS OF DOLLARS BUT NOTHING, NO AMOUNT OF MONEY WILL MAKE UP FOR THE AMOUNT OF TIME HE SPENT AWAY FROM HIS FAMILY.

I WOULD LIKE TO THANK COUNCILWOMAN GREEN FOR BRINGING THIS LEGISLATION AND ALLOWING ME TO SIGN ONTO IT.

THANK YOU.

PRESIDENT JAMES: THANK YOU.

COUNCILMAN ACKERSON?

COUNCILMAN ACKERSON: THANK YOU, MR. PRESIDENT.

FIRST AND FOREMOST I WANT TO ASK THE SPONSOR IF SHE WOULDN'T MIND I JOIN HER AS A SPONSOR ON THIS.

I MET WITH DENNY BUTLER ABOUT THIS AND SAW THE EVIDENCE AND HEARD ABOUT WHAT WAS GOING ON AND FRANKLY, I HAVE SPOKEN WITH SOME FRIENDS IN THE A.G.'S OFFICE WHO THEY WANT THIS CASE BUT THEY HAVE GOT TO BE INVITED IN.

THIS CASE IS ONE THAT HAS GONE BEFORE OUR ATTORNEY'S OFFICE AND NONE HAS TAKEN ACTION.

AND YET THIS BODY, BASED UPON THE EVIDENCE, HAS SAID UNANIMOUSLY SO FAR, WE WILL SEE HOW THE VOTE GOES DOWN TONIGHT, THAT THIS IS SOMETHING WE SHOULD INVITE THE ATTORNEY GENERAL'S OFFICE IN TO TAKE A LOOK AT.

IT SHOULD ALL GIVE US CAUSE FOR PAUSE THAT IF 26 OF US, YOU KNOW, OR A DARN CLOSE TO MAJORITY OF US THINK WE THINK THIS IS SOMETHING THAT SHOULD BE INVESTIGATED, THAT THE A.G.'S OFFICE WANTS TO INVESTIGATE THIS, DOESN'T HAVE THE JURISDICTION AT THE MOMENT UNTIL WE INVITE THEM IN, SHOULD GIVE US CAUSE FOR PAUSE THAT THERE HAVEN'T BEEN STEPS TAKEN TO DATE

THAT HASN'T CAUSED THE INVESTIGATION TO TAKE PLACE WITHOUT COMING BEFORE THIS PUBLIC SAFETY COMMITTEE AND HAVING THIS RESOLUTION PASSED.

SO I THINK THE RESIDENTS OF METRO LOUISVILLE WILL HAVE SOME QUESTIONS TO BE ASKED.

THANK YOU, MR. PRESIDENT.

PRESIDENT JAMES: THANK YOU, COUNCILMAN.

COUNCILWOMAN MADONNA FLOOD?

DEAN AND PRESIDENT OF THE J.L. ROBERTS SCHOOL OF RELIGION,

PRESIDENT OF THE CHRISTIAN EDUCATION DEPARTMENT OF CENTRAL DISTRICT

BAPTIST ASSOCIATION, INSTRUCTOR, PASTOR CONFERENCE COORDINATOR FOR THE

SO WE NEED TO THINK ALL THE TIME HOW CAN WE MAKE IT CONVENIENT FOR EVERYBODY TO TRAVEL OUR COMMUNITY AND NOT BE UPSET AT GRIDLOCK.

MOST PEOPLE LIKE CONVENIENCE.

THEY DO NOT LIKE GRIDLOCK.

AND SO I NEED YOUR ALL'S HELP AS WE GO ALONG AND UNDERSTAND WHEN I'M AGAINST SOMETHING IT'S NOT BECAUSE I'M AGAINST DEVELOPMENT.

BECAUSE WE OUGHT TO THANK DEVELOPERS, THEY ARE HELPING US OUT.

GIVING US SOMETHING WE NEED.

PLACES FOR PEOPLE TO LIVE, PLACES TO SHOP.

BUT WE NEED TO HELP THEM TO MAKE SURE THERE ARE ADEQUATE ROADS SO THEIR BUSINESS DOESN'T FAIL BECAUSE WE DIDN'T DO OUR JOBS.

SO I DON'T WANT TO SOUND LIKE A NUT, BUT SOMETIMES I DO.

SO I'M FOR THIS AND I APPRECIATE IT.

BUT MR. PRESIDENT, JUST FOR ONE MOMENT, I'M EMBARRASSED A LITTLE BIT.

BARBARA SHANKLIN IS ALWAYS HERE AND I DIDN'T DO MY JOB.

I'M EMBARRASSED.

BUT LET ME TELL YOU.

A LOT OF PEOPLE WANT TO PRAISE US FOR A LOT OF DIFFERENT THINGS.
WE DON'T NEED PRAISE.

WE NEED TO THINK ABOUT PEOPLE WHO DO THINGS ALL THE TIME WITHOUT ANYBODY SAYING LOOK WHAT THAT PERSON DID AND WHEN YOU RECOGNIZE SOMETHING A PERSON THAT'S DONE THAT'S REALLY NICE, AND I APPRECIATE BARBARA AND MARY AND CHERI FOR TAKING TIME TO NOTICE THINGS PEOPLE HAVE DONE, THEY NEED RECOGNITION AND I THINK IT'S GREAT.
