AN ORDINANCE APPROPRIATING ~~\$23,500~~ \$26,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,000 EACH FROM DISTRICTS 12 AND 24; \$2,000 EACH FROM DISTRICTS 14, 15, AND 25; \$1,500 EACH FROM DISTRICTS 3 AND 13; \$1,000 EACH FROM DISTRICTS 1, 2, 3, 5, 6, 10, 20, 22, ~~AND 23~~ AND 26; \$750 FROM DISTRICT 17; \$500 EACH FROM DISTRICTS 7 AND 9; AND \$250 FROM DISTRICT 4; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LEUKEMIA & LYMPHOMA SOCIETY, INC. FOR PROGRAM EXPENSES ASSOCIATED WITH “LIGHT THE NIGHT WALK” AND OPERATING EXPENSES. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$23,500~~ \$26,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 each from Districts 12 and 24; \$2,000 each from Districts 14, 15, and 25; \$1,500 each from Districts 3 and 13; \$1,000 each from Districts 1, 2, 3, 5, 6, 10, 20, 22, ~~and 23,~~ and 26; \$750 from District 17; \$500 each from Districts 7 and 9; and \$250 from District 4; through the Office of Management and Budget, to the Leukemia & Lymphoma Society, Inc. for program expenses associated with “Light the Night Walk” and operating expenses.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
