Each department has a different process (of course), but broken out. . .

(1) Louisville Metro Parks: \$238/permit

*Robyn Richards asked that you e-mail her direct to confirm your official approval of this fee/payment; E-Mail: robyn.richards@louisvilleky.gov

(2) Louisville Special Events: \$200 (\$75/permit and \$125/tent permit)

*Audrey Knigge will be sending you/me an e-mail with invoice for your reply of approval/payment.

(3) State: \$250/tent permit

*I literally walked into Audrey's office today for our meeting to find this was just discussed in her meeting prior and new addition for all tents (retroactive to 2014) going forward. Talk about timing. I've a point from Audrey to connect with to share same paperwork provided her...and namely for another "fee." It associated/addendum to the Spécial Events office/permit/fees.

I saw you the other day in Crescent Hill but couldn't make it to you quick enough for a hello (since our last e-mails and time sitting next to one another a bit back at Original Highlands Assoc. Meeting. First, wanted to wish you luck on your Metro Council race. I'm pulling for you!

Second, prior to copying Brian Boles (or other Metro Council contacts), wanted to touch base to pick your brain about our annual event that will be on June 11th in Cherokee Park, and post-race party at Bearn's Highlands. I know things from your/Councilperson Owens' district are in play, but would love the continuity in support...and leverage across him (as well as provide exposure for yourself as result). Not sure how that would fully look, but again wanted to see if we could reach out for support (and any other Councilpersons like year's past) for pick-up of our Metro Parks (and now Special Events) permits. Total cost would be roughly \$500.

From the government side of things, we've already got Jefferson County Sheriff's Dept. back again, and looking like Louisville Water Co. All that coupled with our returning corporate partners is going to make for a great year. Last year we raised \$13,350 for YMCA Safe Place and other area groups. Hoping for a repeat (or more) this year!
