AN ORDINANCE APPROPRIATING—~~\$16,000~~ \$20,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER:—~~\$5,000~~ \$8,000 FROM DISTRICT 24; \$1,000 EACH FROM DISTRICTS 9, 12, 13, 17, AND 21; \$500 EACH FROM DISTRICTS 2, 3, 4, 6, 7, 10, 14, 15, 16, 22, 23, AND 25; AND \$250 EACH FROM DISTRICTS 1, 5, 18, AND 20; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE COALITION FOR THE HOMELESS, INC. FOR PROGRAMMING EXPENSES ASSOCIATED WITH PROJECT STAND DOWN AND THE “GIVE-A-JAM” EVENT. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of—~~\$16,000~~ \$20,000 is hereby appropriated from Neighborhood Development Funds in the following manner: —~~\$5,000~~ \$8,000 from District 24; \$1,000 each from Districts 9, 12, 13, 17, and 21; \$500 each from Districts 2, 3, 4, 6, 7, 10, 14, 15, 16, 22, 23, and 25; and \$250 each from Districts 1, 5, 18, and 20; through the Office of Management and Budget, to The Coalition for the Homeless, Inc. for programming expenses associated with Project Stand Down and the “Give-A-Jam” event.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
