Below is the current review of the development in question. As stated on the phone, the development plan shown operates under the requirements for a Traffic Impact Study per KYTC requirements. We both understand that this is likely by design.

1. The sewer line for this project is preferred to be installed on the West side of US 42 if installed in ROW. I believe that is the engineer's and developer's intention.
2. **KYTC is okay with the concept on the plan with the exception of the comments in this review. This is just a preliminary okay. KYTC will review again if or when construction plans are submitted, and reserve the right to change or qualify the approval when construction plans are submitted for review.**

Kenny,

It was our understanding that the last remaining issue on this project was related to KYTC/MSD sewer alignment issues as stated in the below comment:

Per the attached KYTC email, the proposed sewer alignment does not meet KYTC policies. Therefore, I cannot approve the plan until they can revise the alignment or get conceptual approval from KYTC.

"Has this alignment been verified for utility conflicts? From memory there is a waterline on the same side of the road and approximately in the same location. Your plan shows a 16" waterline, but has its location been field verified for no conflict?"

Regardless, this does not seem to be in compliance with KYTC's Permits Policy regarding new longitudinally installed facilities (attached). The line appears to be proposed under shoulder areas, inside the clear zone and the crossing is supposed to be perpendicular to the roadway"

Does KYTC have any outstanding issues with this project. I've submitted the most recent version in my records from November 2019.
