Extension Board

Statutory Authority: KRS 164.630 - .660

Ordinance Authority: LMCO 32.330 - .332

Board Purpose:

Aid in disseminating among the people of Kentucky useful and practical info on agriculture, home economics, and rural and community life in conjunction with the director of the Kentucky cooperative extension service of the College of Agriculture of the University of Kentucky.

An extension council is set up under regulations approved by the director of extension (Director of the Ky cooperative extension service of the College of Agriculture of UK. An extension council has not less than 15 members and not more than 40. All members are appointed by groups and organizations of the county whose major interest is in agriculture and home economics such as farm bureaus, homemaker councils, 4-H club councils and other commodity groups.

Library Advisory Commission

Statutory Authority: KRS 173.105

Ordinance Authority: LMCO 32.370(D)

Board Purpose:

Authority to adopt bylaws. Sole authority to determine the library materials to be purchased and kept by the library; sole authority for the determination of the expenditures from gifts and grants donated to the library; may make recommendations on other activities of the library at the request of the Mayor; contract and be contracted with; sue and be sued; acquire and hold real and personal property;; mortgage property; may issue bonds for the purpose of making improvements, repairs, or paying off any indebtedness it may owe.

How Appointed: Appointed by Mayor with approval of Council.

Lyndon Fire Protection District

Statutory Authority: KRS 75.031

Ordinance Authority: LMCO 32.935

Board Purpose:

The trustees of a district are authorized to establish and operate a fire department as provided in KRS 75.040(6) and to levy a tax upon the property in the district.

How Appointed: Appointed by Mayor with approval of Council.

Metropolitan Sewer District (MSD)

Statutory Authority: KRS 76.030 et. seq.; 65.008; 65.060

Ordinance Authority: LMCO 32.820

Board Purpose: The sewer district through its board, is empowered to have jurisdiction, control, possession and supervision of the existing sewer and drainage system; to maintain, operate, reconstruct, and improve the system; to acquire and hold or dispose personal and real property; to sue and be sued; to contract and contracted with; to borrow money and issue negotiable bonds; to fix and collect sewer rates, rentals and other charges; to prepare or cause to be prepared and thereafter revise or adopt plans, designs, and estimates of costs pertaining to the existing and future sewer and drainage system; make rules and regulations

How Appointed:

No more than 5 members shall be affiliated with the same political party.

No more than 1 can reside in any one senatorial district. Must be 25 years of age or older.

Must be residents of County for at least 3 years prior to appointment.

No officer or employee of Metro government is eligible for appointment.

PARC

Statutory Authority: None

Ordinance Authority: LMCO 32.500 – 32.502

Board Purpose:

To service the City's existing parking facility needs and the development of strategies to meet future needs.
