I CERTAINLY DO.

I WANTED TO POINT OUT THAT APRIL, SINCE WE ARE CLOSE TO THE END OF APRIL, THAT IT IS DISTRACTED DRIVING AWARENESS MONTH.

AND NOW THAT I HAVE A TEENAGE DRIVER IN MY HOME, I HAVE EVEN BECOME MORE CONSCIOUS OF THE DANGERS OF DISTRACTED DRIVING AND WANTED TO JUST BRING SOME ADDITIONAL AWARENESS TO THIS.

WE HAVE HAD SOME GREAT CORPORATE PARTNERS ACROSS OUR COMMUNITY AND ACROSS THE NATION WHO HAVE ALSO BEEN VERY GOOD ABOUT DOING PUBLIC SERVICE AWARENESS MESSAGES LATELY, AND I THOUGHT IT WOULD BE GREAT FOR US TO DO THAT IN LOUISVILLE AS WELL, AS WE ARE ONE OF THE AREAS IN THE U.S. THAT PAYS A HIGHER INSURANCE RATE FOR OUR CARS.

SO I WOULD LIKE TO READ INTO THE RECORD.

WHEREAS DISTRACTED DRIVING IS A SERIOUS ISSUE IN OUR ROADWAY, CLAIMING THOUSANDS OF LIVES AND INJURYING THOUSANDS MORE EACH YEAR IN THE UNITED STATES.

AND WHEREAS THE CENTERS FOR DISEASE CONTROL AND PREVENTION SAY THAT EACH DAY IN THE UNITED STATES APPROXIMATELY NINE PEOPLE ARE KILLED AND MORE THAN 1,000 ARE INJURED IN CRASHES THAT ARE REPORTED TO INVOLVE A DISTRACTED DRIVER.

AND WHEREAS THE NATIONAL SAFETY COUNCIL SAYS DRIVER DISTRACTION OFTEN RESULTS IN CRASHES DUE TO DELAYED BRAKING TIME AND FAILURE TO SEE TRAFFIC SIGNALS.

AND WHEREAS THE NATIONAL INSTITUTES OF HEALTH FOUND THAT DISTRACTED DRIVING, PARTICULARLY AMONG NEW DRIVERS, SUBSTANTIALLY RAISES THE RISK FOR CAR CRASHES AND NEAR-CRASHES.

AND WHEREAS THE NATIONAL HIGHWAY TRAFFIC SAFETY ADMINISTRATION ESTIMATES THAT AT ANY GIVEN DAYLIGHT MOMENT APPROXIMATELY 660,000 PEOPLE ACROSS AMERICA ARE USING CELL PHONES OR MANIPULATING ELECTRONIC DEVICES WHILE DRIVING.

AND WHEREAS IN 2014 IT BECAME ILLEGAL IN THE COMMONWEALTH OF KENTUCKY TO USE A PERSONAL COMMUNICATION DEVICE TO READ, WRITE, OR SEND A TEXT MESSAGE WHILE OPERATING A VEHICLE THAT IS IN MOTION.

THE PROHIBITION INCLUDES REGULAR TEXT MESSAGES, INSTANT MESSAGES, AND E-MAILS.

WHEREAS APRIL IS DISTRACTED DRIVING AWARENESS MONTH.

AND WHEREAS INCREASED AWARENESS ABOUT THE DANGERS OF DISTRACTED DRIVING WILL RESULT IN SAFER ROADWAYS IN METRO LOUISVILLE.

AND NOW THEREFORE BE IT RESOLVED THAT LOUISVILLE METRO COUNCIL DOES HEREBY RECOGNIZE APRIL AS DISTRACTED DRIVING AWARENESS MONTH IN LOUISVILLE AND ENCOURAGES ALL CITIZENS OF LOUISVILLE TO PUT DOWN ANYTHING THAT TAKES YOUR ATTENTION AWAY FROM THE TASK OF SAFE DRIVING.

WHEREAS HE WAS A GRADUATE OF FLAGE HIGH SCHOOL IN 1957 AND DONATED HIS LIFE TO THE LABOR MOVEMENT.

A MEMBER OF THE NATIONAL AEROSPACE AND MACHINE WORKERS IN 1958. SELECTED TO SERVE AS THE POLITICAL AND LEGISLATIVE DIRECTOR OF THE KENTUCKY AFL-CIO IN 1972.

WHEREAS IN 1992 HE WAS EMPLOYED BY THE KENTUCKY LABOR DISTRICT COUNCIL AS THE ADMINISTRATOR OF THE LABOR/EMPLOYERS COOPERATION AND EDUCATION TRUST FUND.

WHEREAS IN 1998 HE WAS EMPLOYED BY THE POLITICAL DEPARTMENT OF THE NATIONAL AFL-CIO WHERE HE WORKED IN MANY POLITICAL CAMPAIGNS AND EVENTUALLY RETIRED IN 2001.

WHEREAS HE WAS NAMED THE LABOR RECIPIENT OF THE 1999 KENTUCKY LABOR MANAGEMENT AWARD.

THE LOUISVILLE/JEFFERSON COUNTY DEMOCRATIC PARTY VOLUNTEER OF THE YEAR AWARD IN 2009.

AND THE METRO DEMOCRATIC CLUB SERVICE AWARD IN 2017.

WHEREAS RAY WAS HONORABLY DISCHARGED IN 1965 FROM YOUR KENTUCKY NATIONAL GUARD.

WHEREAS RAY SERVED SEVERAL TERMS AS PRESIDENT OF THE LOUISVILLE/JEFFERSON COUNTY REVENUE COMMISSION, A MEMBER OF THE LOUISVILLE MANAGEMENT COMMITTEE, LOUISVILLE URBAN LEAGUE, JEFFERSON COUNTY DEMOCRATIC EXECUTIVE COMMITTEE, METRO UNITED WAY, SPECIAL SKILLS OLYMPIC COMMITTEE, LOUISVILLE GARDENS BOARD MEMBER, STATE UNEMPLOYMENT INSURANCE COMMITTEE.

THIS PROGRAM WAS STARTED BY BROTHERS SHAUN AND NICHOLAS IN THEIR HOME SIX YEARS AGO.

THEIR PROGRAM IS DESIGNED TO CREATE THE OPPORTUNITY FOR YOUTH TO DEVELOP.

ALTHOUGH THEIR SUCCESS IS MEASURED WITH TRUE BOXING, THE GOAL OF THE PROGRAM IS TO DEVELOP YOUNG MEN INTO CONTRIBUTING, PRODUCTIVE PEOPLE IN OUR COMMUNITY.

THEIR FOCUS IS ON MENTORING YOUNG PEOPLE AND TRYING TO CREATE OPPORTUNITIES AND SERVICES THAT THESE YOUNG PEOPLE DO NOT HAVE ACCESS TO.

IN 2017 SELECT BOXING CAME UP WITH SOUTHWEST YOUTH SPORTS, A 501(C)(3) STARTED BY TROY BROOKS AND TOGETHER THEY OPENED THEIR FIRST PUBLIC FACILITY AT 2801 FLOYD STREET.

THE PURPOSE TEAMING UP WITH SOUTHWEST YOUTH WAS TO GET MORE YOUNG PEOPLE IN OUR COMMUNITY AN OPPORTUNITY TO COMPETE IN THE SPORT OF BOXING AND PROVIDE SERVICES TO OUR UNDERSERVED YOUTH.

THE BOXING GYM IS OPEN FIVE DAYS A WEEK.

THEY PROVIDE MEALS, MINIMUM GYM FEES OR FEE WAIVERS, CLOTHING, EQUIPMENT AND TRAVEL COST AND TRAVEL COSTS FOR THEIR YOUNG ATHLETES.

THEY ARE ABLE TO PROVIDE THESE SERVICES VIRTUALLY AT NO COST FOR THESE KIDS THEY WORK WITH.

THEY ARE SHINING EXAMPLES FOR HOW WE CAN ALL BE INVOLVED WITH THE YOUTH IN OUR COMMUNITY.

SO TODAY, WE HAVE A PROCLAMATION FOR THE COACHES AND THE TEAM.

WE ALSO HAVE ONE FOR EACH AND EVERY ONE OF THE ATHLETES HERE WITH US TODAY.

I WANT TO WELCOME AND RECOGNIZE A FEW OF THE FAMILIES AND FRIENDS OF THE LATE JULIUS FRIEDMAN, JERRY CRAWLEY, SANDRA AND MICHAEL HISER AND MARY JANE READILY, THIS IS A RESOLUTION HONORING, JULIUS FRIEDMAN AND KENILWORTH PLACE, AT BARDSTOWN TO BE NAMED JULIUS FRIEDMAN IN HIS HONOR.

I WILL BRIEFLY READ THE RESOLUTION.

WHEREAS THE LATE JULIUS FRIEDMAN IS AN INTERNATIONALLY CELEBRATED GRAPHIC DESIGNER, WHOSE WORK HAS APPEARED IN NUMEROUS PLACES, AND NATIONAL GALLERY OF ART IN WASHINGTON D.C. AMONG OTHER GALLERIES AND MUSEUMS ACROSS NORTH AMERICA, ASIA AND EUROPE.

HE WAS BORN IN 1943 TO MARTIN AND EDNA FRIEDMAN AND SPENT THE VAST MAJORITY OF HIS LIFE WITH FOCUS ON DESIGN FOR NON-PROFITS AND SUPPORT FOR THE ARTS.

WHEREAS MR. FRIEDMAN STUDIED ARCHITECTURE AT UNIVERSITY OF KENTUCKY BUT RETURNED TO LOUISVILLE BEFORE HIS FATHER'S SUDDEN DEATH, RETURNED TO UNIVERSITY OF LOUISVILLE.

HE WAS RECIPIENT OF COLLEGE AND DESIGNERS ASSOCIATION WHICH RECOGNIZES THOSE WHO DONATED THEIR TIME AND SUPPORT TO FURTHER U.C.A.'S

GOALS AND CO-OWNED IMAGES GALLERY WITH HIS SISTER LOCATED ON THE SECOND FLOOR OF WHAT IS NOW THE FRASER MUSEUM.

WHEREAS IN 2016, THE FRASER MUSEUM FEATURED JULIUS FRIEDMAN, 50-YEAR RETROSPECTIVE, FEATURED THE ICONIC POSTERS PART OF THE INTERNATIONAL ARTS AND CULTURE.

HIS FRESH PAINT POSTER FEATURING THREE EGG YOLKS IN THE PRIMARY COLORS.

WHEREAS UNIVERSITY OF LOUISVILLE IS HOME TO A COLLECTION OF HIS WORK THAT JULIUS FRIEDMAN COLLECTION, WHEREAS EVEN IN DEATH HIS WORK IS GIVING BACK TO THE COMMUNITY THROUGH THE JULIUS FRIEDMAN FOUNDATION FUNDED BY THE SALE OF HIS WORK AND PROVIDES GRANTS TO YOUNG PEOPLE WHO SEEK TO FOLLOW IN HIS FOOTSTEPS.

BE IT RESOLVED BY LOUISVILLE METRO COUNCIL, ONE JULIUS FRIEDMAN'S ARTISTIC CONTRIBUTION TO LOUISVILLE METRO IS HEREBY RECOGNIZED WITH PLACEMENT OF HONORARY STREET SIGN AT KENILWORTH, AND DESIGNATED JULIUS FRIEDMAN WAY.

SECTION TWO DEPARTMENT OF PUBLIC WORKS DIRECTED TO MOVE FORWARD WITH FABRICATION AND INSTALLATION OF THE HONORARY SIGN UPON THE PASSAGE OF THIS RESOLUTION AND FUNDS TO COVER THE EXPENSE AND THIS SHALL TAKE EFFECT UPON ITS PASSAGE AND APPROVAL.

I WANT TO ADD ALSO IN RECENT WEEKS AND MONTHS, WE PASSED A RESOLUTION ACCEPTING A DONATION FROM THE FRASER HISTORY MUSEUM, JULIUS FRIEDMAN, AS A RESULT 224 PIECES OF JULIUS'S ART WILL BE DONATED AND DISPLAYED THROUGHOUT CITY BUILDINGS ACROSS JEFFERSON COUNTY.

THIS IS A WONDERFUL TRIBUTE AND I'M GLAD WE WILL BE ABLE TO RECOGNIZE JULIUS, RIGHT IN THE HEART OF THE HIGHLANDS WHERE HE LIVED FOR SO MANY YEARS.

I MOVED TO BE NEAR ONE OF HIS GALLERIES AT ONE POINT ACROSS THE STREET AT SIXTH AND MAIN.

JULIUS HAD A WAY OF TAKING ORDINARY SIMPLE OBJECTS WE LOOK AT EVERYDAY AND SEVER IN THEIR MOORINGS AS HE PLACED THEM IN PHOTOGRAPH AND CAUSE YOU TO SUSPEND YOUR DISBELIEF IN WAYS YOU COULD IMAGINE BEING THAT EGG OR SCOOP OF ICE CREAM IN THE FRENCH HORN, HE PRODUCED FOR OUR FAMOUS LOUISVILLE ORCHESTRA.

WHAT DOESN'T GET TALKED ABOUT A LOT IS ONE OF THE PROJECTS JULIUS DID IN THE LAST FEW YEARS OF HIS LIFE, ALWAYS WORKING WITH NON-PROFITS AND USING HIS GOD-GIVEN TALENTS TO LIFT OTHERS UP.

HE PHOTOGRAPHED ONE OF OUR TOP BALLERINA ERICA OUT IN A FIELD IN BARNES AND NATURE IN WAYS THAT PRODUCED IMAGES NO MATTER HOW YOU TURN THEM, YOU SEE SOMETHING VERY SPECTACULAR AND SOMETHING DIFFERENT AND IT'S ALSO AN HONOR AND PRIVILEGE TO KNOW THAT CAROL CIPHER IS IN THE AUDIENCE WITH US THIS EVENING.

MS. CIPHER, THANK YOU VERY MUCH FOR BEING HERE.

GOD BLESSED JULIUS AND THE LIFE HE LIVED.

HE SAID ON A TELEVISION INTERVIEW AT ONE TIME HE THINKS HE MUST HAVE BEEN DROPPED BY A MYSTERIOUS STRANGER ON A DOORSTEP BECAUSE YOUR FATHER WAS A DRUGGIST AND JULIUS SAID HE WASN'T EXPOSED TO ART GROWING UP AS MUCH AS PEOPLE MIGHT HAVE THOUGHT HE WAS.

ON THE SECOND WHEREAS ON THE ORDINANCE, AT THE END OF THE SENTENCE WE WILL ADD WITH AN AMENDMENT TO BINDING ELEMENT NUMBER 7.

AT THE END OF SECTION 1, IT WILL START, 1072, WITH AN AMENDMENT RETURNING BINDING ELEMENT NUMBER 7 TO ITS ORIGINAL FORM AS SUBMITTED IN THE MARCH 15TH, 2018 PLANNING COMMISSION STAFF REPORT, THE BINDING ELEMENT WILL READ AS FOLLOWS, NUMBER 7, NO OVERNIGHT IDLING, OR IDLING OF TRUCKS WHILE LOADING AND UNLOADING EQUIPMENT SHALL BE PERMITTED ON SITE AND I MOVE THAT AMENDMENT.

THE APPLICANT JUST WASN'T INTERESTED IN THAT.

I REACHED OUT AGAIN VIA THEIR ATTORNEY AND THE COUNTY ATTORNEY TO SEE IF THERE WAS ANY INTEREST AND THERE WASN'T, THEY REALLY WANT THIS TO GO AHEAD AND STAND SO THEY COULD MOVE FORWARD, SO I SUGGEST YOUR YES-VOTE ON THIS TONIGHT.

I WILL VOTE YES FOR ALL THE REASONS PEOPLE TALKED ABOUT.

I HEARD THERE WAS ALSO A RULE THAT I HADN'T LEARNED ABOUT.

I WANTED TO GET CLARIFICATION, SINCE THE COUNTY ATTORNEY IS HERE, WHEN YOU APPLY FOR A ZONING CHANGE AND IT'S DENIED YOU ARE BARRED FROM APPLYING IN THE SAME PROPERTY FOR TWO YEARS?
