Hello, maybe your office can help me in regards to adding a new street light on my street. Specifically in front of the address of 413 Atwood St on an existing utility pole. Back in the spring I contacted Metro 311, public works and LG&E. Received a work order number, and never heard anything back. After a few months, I contacted Metro 311 to check the status. They had no record of a request being made. 311 then sent me over to public works where I was informed that LG&E needs to be contacted. Upon speaking with LG&E, they said that a request needs to be approved from Metro and Public works before said light would be installed on a city street. As you can tell, this turned into an endless loop where no one was able to give me any information or updates. Everyone I spoke with couldn't point me in the right direction to get this accomplished. At that point I contacted your office via voice-mail and once again I never heard anything back. At that point, I gave up out of frustration. The concern I and a few neighbors have and the reason we were wanting the additional street light, is that our street (Atwood) dead-ends into interstate 65 at 413 Atwood Street. The dead-end is very dark and at times on the states side on the states fence is overgrown. In the past we've had issues with homeless and others passing through Louisville setting up camp in these overgrown and dark areas. Recently, Metro or the state has added "no camping" signs to the interstate right of way and that seems to have helped with the folks setting up camp. However, the dead end of Atwood Street still remains dark and a safety hazard to residents. Is there anyway your office can see about adding a street light to the utility pole in front of 413 Atwood?
