Street Name Change from High Wickham Place to James Thornton Way

## CASE SUMMARY/BACKGROUND/SITE CONTEXT

This proposal is for a street name change for High Wickham Place, a private roadway that will run approximately 650' northwest from Old Henry Road to its terminus. The new street will be named James Thornton Way. The applicant owns the properties on which the recorded private road is located. This property has not been fully developed at this time and, therefore, aerial and zoning maps do not reflect the recorded street layout on the site.
