- Best rates for all golf courses
- Comparison of rates between other Metro courses
- Comparison of rates between 9-hole and 18-hole of other Metro courses
- Comparison of rates between seasons, weekdays, weekends, twilight, dynamic pricing and special events
- Cost of original purchase along with payments and the investment
- Purpose and justification of higher rates for Quail Chase and not other Metro courses
- Negative reviews
- Tour of the courses will be necessary for rates to be established
- Prices apply to all 10 Metro courses due to the Ordinance in place
- Golf being a depressed sport at this time
- Possibility of all contract agreements being the same
- Environment could be if the course is successful, the golf pro is successful, and Metro is successful in terms of rates to determine rates
- Consistently across the board, all courses be in good shape
- The current structure of fees has been in place since 2006
- Codifying of fees versus amending each time for rate adjustments
- Does Metro Council need to be involved or leave it to just Metro Parks
- Golf pros follow the Ordinance for fee rates
- Save public golf by keeping things simple
- Tier system for courses
