

ORDINANCE NO. 039, SERIES 2020

AN ORDINANCE APPROPRIATING ~~\$5,000~~ ~~\$11,000~~ \$12,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$4,500 FROM DISTRICT 21; \$3,000 FROM DISTRICT 15; \$1,000 FROM DISTRICTS 13 AND 25; \$500 FROM DISTRICTS 3, 10, 12, AND 14; AND \$250 FROM DISTRICTS 1 AND 17, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO SOUTH LOUISVILLE COMMUNITY MINISTRIES, INC. ("SLCM") FOR EXPENSES ASSOCIATED WITH FAMILIES HELPING FAMILIES AND SUPPORTING SLCM'S EMERGENCY RENTAL ASSISTANCE (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$5,000~~ ~~\$11,000~~ \$12,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$4,500 from District 21; \$3,000 from District 15; \$1,000 from Districts 13 and 25; \$500 from Districts 3, 10, 12, and 14; and \$250 from Districts 1 and 17, through the Office of Management and Budget, to South Louisville Community Ministries, Inc. ("SLCM") for expenses associated with families helping families and supporting SLCM's emergency rental assistance.


SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.


SECTION IV: This Ordinance shall take effect upon its passage and approval.
