Hello, Aaron:

Thank you for the opportunity to provide some clarity and chronology of the Olmsted Parkways Bicycle and Pedestrian Improvements project.

Per your request for the information that was reviewed and discussed at the 6/5/18 Metro Council committee meeting, here are the project maps that describe the entire Olmsted Parkways Bicycle and Pedestrian Improvements project along approximately 8 miles of Southwestern Parkway, Algonquin Parkway, and Southern Parkway – and show which sections are funded with CMAQ grants and which are funded with SLO funds.

- First map illustrates the segments for Phase II (Final) Design – pink for the CMAQ-funded segments, blue for the SLO-funded segments
- Second map illustrates the segments for Construction – pink for CMAQ-funded segments, yellow for the SLO-funded segments

As was stated in the Council committee meeting, these maps had been prepared for use by the consultant team in describing the distribution of remaining Design funds for this project in discussion with KY Transportation Cabinet staff, who provide oversight on these federally funded transportation projects. I did not anticipate that these were necessary elements of the resolution process. I appreciate your effort to complete the record of documentation in committee discussions.

Here are the revised maps that the Metro Council members requested. The labeling describes them.

- One is the extent of Southwestern Parkway and Algonquin Parkway that will be addressed using these CMAQ funds in the **Phase II (Final) Design** phase.
- The second shows the extents of Southwestern Parkway and Algonquin Parkway that will be addressed using these CMAQ funds in the **Construction** phase.

The extent of work shown is as much as this amount of funding will cover. The rest of the project will use other federal transportation funding – which is not a part of this resolution.

I apologize again for the unclear/incomplete information that was presented before this committee. I appreciate the Metro Council members' understanding and willingness to amend the resolution in this expeditious manner.
