Subject: Meadowview Cemetery update

We have been working with Jeff O'Brien and his staff to reduce the existing set back limits of the cemetery from 30' to 18' on the East side of the property and 5' on the North side. I am happy to let everyone know that Monday we picked up the approved Community Facility Review plan. This results in the availability of approximately 160 new burial sites. Our fence contractor is scheduled to move the fence to the new setback limits in the next couple of weeks which will not impact the existing grave sites.

We have also sent an application to KYTC to purchase the remaining 0.4 acres between Interstate 265 and Meadowview Cemetery. That should be enough space for another 150-160 burial sites. I have not heard anything back from KYTC yet, but do not anticipate any issues other than the time it will take to obtain that property.

This is just a short term solution while we continue our search for a larger piece of property that will better meet our needs.
