CW Welch and CW Fowler,

Following up on recent discussions we've had related to implementation of the South Points Scenic Area initiative, here is a funding request for signage-related expenses. As you are well aware since you've been an integral part of the committee working to make this a reality, KYTC has approved \$80,000 in funding for installation of highway signage at three locations along I-65 and I-264 to direct motorists (i.e., tourists) to all the wonderful attractions in South and Southwest Louisville including, Jefferson Memorial Forest, Iroquois Park and Amphitheater, Riverside: the Farnsley-Moremen Landing, Waverly Parks, Riverview Park, and the Louisville Loop (among others). KYTC approved these highway signs contingent upon us placing the South Points Scenic Area Logo (attached) on top of the existing way-finding signs that were installed in south and southwest council districts along main travel routes in the area in 2012. To implement that portion of the project, we would like to request a total of \$21,419 in funding for this portion of the overall project and to leverage the KYTC funding support. That includes placement of logo "hats" on existing signs and installation of two additional required signs with breakaway posts and panels.

Concurrently with the signage installation, we are working with the SW Dream Team and the Louisville Convention and Visitor's Bureau to develop necessary marketing and promotional materials (maps/brochure/website, etc) that will allow us to roll-out this project in the summer. This project will benefit tourism in south and southwest Louisville. We anticipate that once implemented this project will result in a significant increase in tourism to the above mentioned attractions with associated benefits to local businesses and community as a whole.
