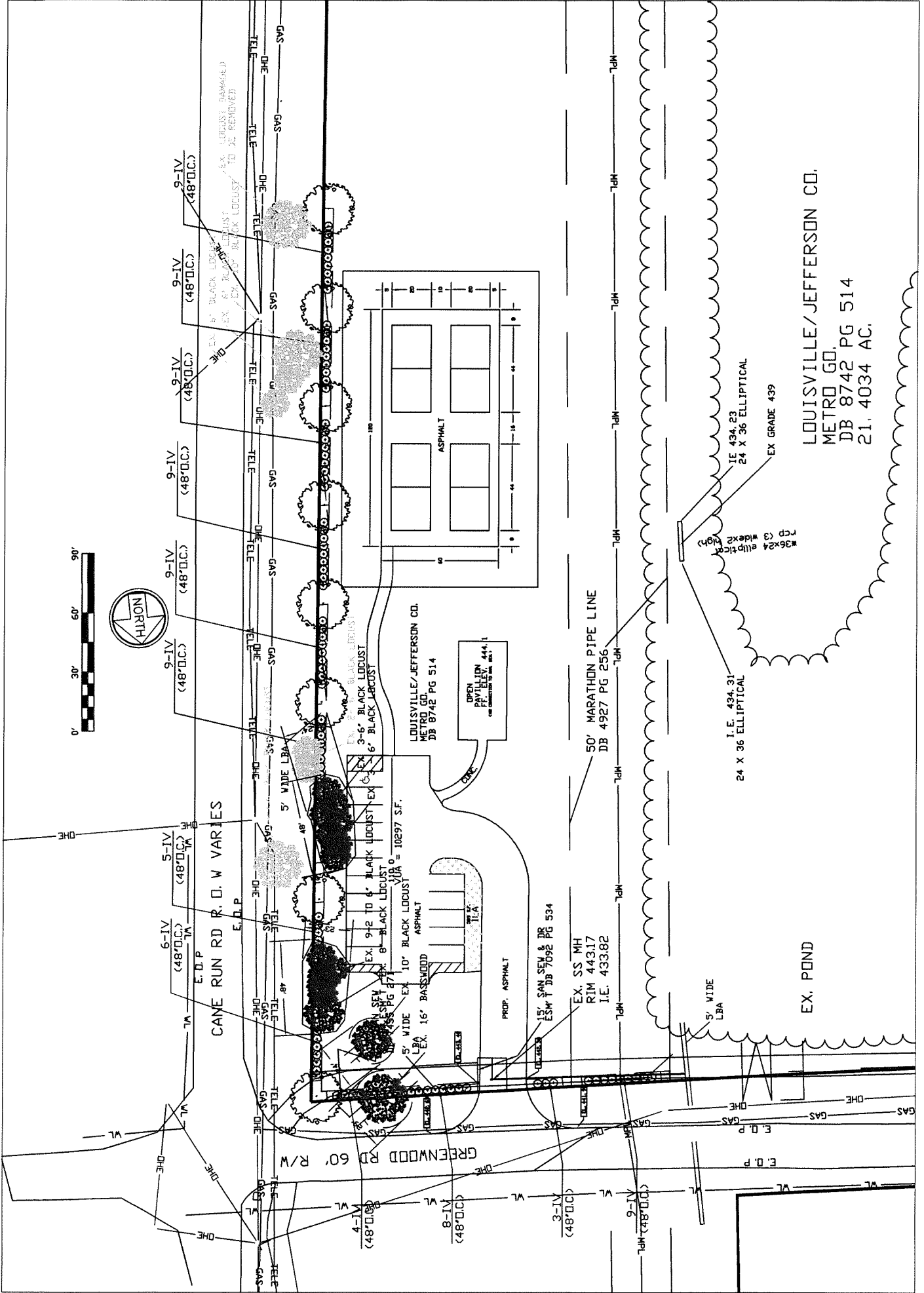

Heather,

Please see attached preliminary layout and additional information for the pickleball courts at Riverview Park.

We will need to discuss layout, lighting, and budget before we move forward.

1. Layout – We should have enough room to build (4) courts in the field adjacent to the pavilion at the corner of Cane Run and Greenwood. I suggest we build the courts similar to the “Competitive Play” layout as attached. This layout is more friendly and allows more room behind / between the courts.
2. Lighting – We need enough light to eliminate shadows while playing in the evening or night. We can do this by using four “sport lights” in each corner or use several smaller lights around the perimeter. Cost of sports lighting will be more expensive.
3. Budget - See attached estimate. We should be able to get this under \$350k.

Please review and let’s set up a meeting to discuss details.
