AN ORDINANCE APPROPRIATING ~~\$4,900~~ ~~\$7,375~~ \$9,525 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 FROM DISTRICT 9; \$850 FROM DISTRICT 10; \$725 FROM DISTRICT 4; \$600 FROM DISTRICT 8; \$500 EACH FROM DISTRICTS 2, 13, AND 24; \$350 EACH FROM DISTRICTS 1, 12, 14, 15, 17, 21, AND 25; AND \$300 EACH FROM DISTRICTS 6, 7 AND 20; AND \$250 EACH FROM DISTRICTS 3 AND 16; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LOUISVILLE INDEPENDENT BUSINESS ALLIANCE, INC. TO HELP FUND THE ANNUAL BUY LOCAL FAIR (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (“THE COUNCIL”) AS FOLLOWS:

SECTION I: The sum of ~~\$4,900~~ ~~\$7,375~~ \$9,525 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 9; \$850 from District 10; \$725 from District 4; \$600 from District 8; \$500 each from Districts 2, 13, and 24; \$350 each from Districts 1, 12, 14, 15, 17, 21, and 25; and \$300 each from Districts 6, 7 and 20; and \$250 each from Districts 3 and 16; through the Office of Management and Budget, to the Louisville Independent Business Alliance, Inc. to help fund the annual Buy Local Fair.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
