AN ORDINANCE APPROPRIATING ~~\$5,300~~ ~~\$8,300~~ \$8,850 FROM NEIGHBORHOOD DEVELOPMENT FUNDS (NDF) IN THE FOLLOWING MANNER: \$2,000 FROM DISTRICT 9; \$1,200 FROM DISTRICT 8; \$800 FROM DISTRICT 10; \$750 FROM DISTRICT 14; \$500 EACH FROM DISTRICTS 7, 14, 21, AND 25; \$300 EACH FROM DISTRICTS 2, 5, 12, 13, AND 15, AND 17; AND \$250 EACH FROM DISTRICTS 4 AND 6; \$200 FROM DISTRICT 3; AND \$100 FROM DISTRICT 1; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LOUISVILLE INDEPENDENT BUSINESS ALLIANCE, INC. FOR OPERATING EXPENSES ASSOCIATED WITH THE NINTH (9TH) ANNUAL BUY LOCAL FAIR. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The total of ~~5,300~~ ~~\$8,300~~ \$8,850 is hereby appropriated from Neighborhood Development Funds (NDF) in the following manner: \$2,000 from District 9; \$1,200 from District 8; \$800 from District 10; \$750 from District 14; \$500 each from Districts 7, 14, 21, and 25; \$300 each from Districts 2, 5, 12, 13, and 15, and 17; and \$250 each from Districts 4 and 6; \$200 from District 3; and \$100 from District 1; through the Office of Management and Budget, to the Louisville Independent Business Alliance, Inc. for programming expenses associated with the Ninth (9th) Annual Buy Local Fair to be held at the Louisville Water Tower Park.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
