Andrew,

The Councilman and I visited the District last week. In preparation for the upcoming budget, would you be kind enough to provide estimates of cost to pave the below roads? Please feel free to make any comments, suggestions, etc.

Wolf Pen Branch Rd (*first priority*)(Ratings varied) – The worst areas seem to be in the stretch between Cherry Valley Rd and ending at Chamberlain Ln. The area of 8110 Wolf Pen Branch Rd was horrible.

- I would recommend paving from Chamberlain Lane to 8011 Wolf Pen Branch Road: Estimate \$180,000
- I would also recommend the section from Cherry Valley Road to Spring Farm Road: Estimate \$50,000

Springdale Rd (*second priority*)(Ratings varied) – Worst areas seem to be in the stretch between Asbury Park and Wolf Pen Branch Rd.

- I would recommend paving from near Wolf Pen Branch Road to the I-71 Overpass: Estimate \$160,000
- I am going to check to see if there are any anticipated impacts by the widening of I-265 on the rest of this section beyond the intersection with Wolf Pen Branch.

Chamberlain Ln (from Mint Spring Branch Rd to Brownsboro Rd aka 1694) – (Rating 23)

- Estimate: \$65,000
- As an FYI: Norton Commons can apply to have this section of road closed or it can be discontinued in accordance with KRS Ch. 178. That was the agreement in the Norton Commons Master Plan but it doesn't give a time frame when it will be done. It only says it couldn't be closed before another connection between Chamberlain and Brownsboro has been provided, which it has. It's very doubtful the existing alignment will work for the Norton Commons layout so I anticipate a closure application in the next year or two.

Blankenbaker Ln – (shared with District 7) – The section between Poplar Hill to River Hill (Rated 46) and The section from Dale to Apache (Rated 51)

- I would recommend paving from River Road to Woodside Road. Estimate \$125,000
- Brownsboro Road to Apache Road. Estimate \$25,000

Ky 22 (shared with Dist 7) – Herr Lane to Seminary Dr. –(Rated 42 to 46)

- Brownsboro Road from Herr Ln to Seminary. Estimate \$50,000

Sycamore Woods Court in Woods of St Thomas– (*first priority to HOA*) – Dead end to Sycamore Woods Dr. (Rated 28)

- Estimate: \$11,000

Barbour Manor Dr – (Barbour Ln to Barbour Manor Ct) (Rated 50)

- I wouldn't recommend any paving on Barbour Manor Drive at this time.

Captain Quarters Rd – (Guthrie Beach to River Rd)(Rated 52)

- Estimate: \$38,000

Innes Trace Rd – (Lime Kiln Ln to Innes Trace Ct.) (Rated 44)

- I would recommend paving from Lime Kiln to Regal. Estimate: \$27,000

Creekcrossing Dr in Spring Creek – (Dead end to Running Spring Dr.)(Rated 28)

- Estimate \$30,000

Deer Springs Ct in Spring Creek – (Dead end to Running Spring Dr.)(Rated 31)

- Estimate \$20,000
