AN ORDINANCE APPROPRIATING ~~\$5,700~~ \$6,700 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,500 FROM DISTRICT 15; ~~\$1,000 EACH FROM DISTRICTS 4, 12~~; \$750 FROM DISTRICT 6; \$500 EACH FROM DISTRICTS 14, 17, 21, 13, 9, 16; \$450 FROM DISTRICT 4; TO METRO PARKS DEPARTMENT FOR SOUND AND LIGHTING EQUIPMENT AND ADDITIONAL RENTAL FEES FOR A FREE LOUISVILLE ORCHESTRA CONCERT AT IROQUOIS AMPHITHEATRE (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$5,700~~ \$6,700 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,500 from District 15; ~~\$1,000 each from Districts 4, 12~~; \$750 from District 6; \$500 each from Districts 14, 17, 21, 13, 9, 16; \$450 from District 4; to Metro Parks Department for sound and lighting equipment and additional rental fees for a free Louisville Orchestra concert at Iroquois Amphitheatre.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
