### Call to Order

## Special Discussion

1. [ID 20-1547](#)**Abandoned Vehicles - Cathy Duncan, Facilities Management, Tiffany Smith, Parking Authority River City, and Major Dave Allen, Louisville Metro Police Department**

The following was discussed:

- 45 day rule is once vehicle is towed in, the tow lot would have to wait 45 days to contact rightful owners to get the vehicle back to them
- If vehicle is abandoned after 45 day rule was exhausted the vehicle can be sold at auction or scrapped
- Estimated that there are 4,000 abandoned vehicles on the roadways today
- Auctions are on-line since COVID-19
- Live auctions started in September
- Tow-lot has 4 months of backlog
- Police have been called to help wrecker drivers with enforcement to get vehicle off roadways
- Priority vehicles to be removed off roadways would be those called in by Police for safety reasons, those that Council Members call in and those that are in a position that would be a safety hazard
- Louisville Metro Police Department always contacts an owner by certified mail if stolen vehicle is recovered that was abandoned
- Louisville Metro Police Department also works directly with insurance companies
- Question regarding whether the tow lot was too small before COVID-19
- Question regarding whether there is a temporary overflow spot to store abandoned vehicles
- Question regarding whether Metro Government ever does an amnesty day to waive fines, so owners who can't afford to pay fines can come get there vehicles
- The money accrued from auctions goes into the Metro general funds
- Metro is getting great deal on scrap from vehicles
- Parking garages would only be temporary storage and also would be extremely expensive
- Cannot build the present tow lot into high rise because of large trucks and the land the tow lot is located on would not allow it to be done
- Question about whether Bullitt County was contacted to put tow-lot there
- There is not enough staff to have multiple tow lots

Major Allen stated that in during COVID-19 pandemic, he was instructed by command to stop towing normal abandoned vehicles unless they would cause a safety risk. He also stated that since the middle of July, he was instructed to start towing vehicles again.

Cathy Duncan stated there are 18 acres on Millers Lane in Council Member

Dorsey District. She also stated that there is still 100 vacant spots at fleet available.
