On behalf of D03, the \$65,000 MAP081518PW03 for Gaulbert Avenue new sidewalk project needs to be repealed through the Appropriations Committee. The Gaulbert Avenue project did not qualify for the \$65,000 Federal fund match; therefore, the project was cancelled. The \$65,000 Federal fund match portion of the project was reallocated to D11's Stony Brook Dr new sidewalk project through Ordinance 148, Series 2019 and Filed ID# O-322-19. Once MAP081518PW03 is repealed then the initial D03's \$65,000 MAP match portion will be reallocated to other D03 sidewalk and paving projects.
