AN ORDINANCE APPROPRIATING ~~\$56,000~~ \$70,400 IN NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$11,200 FROM DISTRICT 12; \$8,000 EACH FROM DISTRICTS 7, 23 AND 24; \$6,400 FROM DISTRICT 5; \$4,800 FROM DISTRICTS 3, 10, 11, AND 21; AND \$3,200 FROM DISTRICTS 1, 4, AND 9; AND ~~\$1,600 FROM DISTRICT 11~~ THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO COMMONWEALTH THEATRE CENTER, INC. TO FUND THE PRESENTATION OF "RED RIDING HOOD: A VAUDEVILLE ROMP" AT SCHOOLS THROUGHOUT JEFFERSON COUNTY (AS AMENDED).

SPONSORED BY: COUNCIL MEMBERS PEDEN, GREEN, WOOLRIDGE, BRYANT HAMILTON, HOLLANDER, MULVIHILL, KRAMER, BLACKWELL, JOHNSON, AND FLOOD, LEET, SEXTON SMITH

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$56,000~~ \$70,400 from Neighborhood Development Funds in the following manner: \$11,200 from District 12; \$8,000 each from Districts 7, 23 and 24; \$6,400 from District 5; \$4,800 from Districts 3, 10, 11, and 21; \$3,200 from Districts 1, 4, and 9; and ~~\$1,600 from District 11~~; through the Office of Management and Budget, to Commonwealth Theatre Center, Inc., for programming expenses associated with performances of "Red Riding Hood: a Vaudeville Romp."

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
