I value artificial intelligence, technological progress, economic investment, and the infrastructure needed to support them. Data centers can bring construction activity, tax revenue, improved utility infrastructure, and opportunities for Louisville to participate in a growing part of the economy.</p> <p>At the same time, support for technology and investment should not mean accepting development without meaningful regulation, public oversight, or protection from community risks. The economic benefits of these projects must be weighed against their substantial demands on electricity, water, land, public infrastructure, and surrounding neighborhoods. Those burdens should not be shifted to residents, ratepayers, or communities that are already dealing with concentrated industrial impacts.</p> <p>I appreciate the draft regulations' attempt to limit hyperscale developments, including the proposed maximum size and additional review for larger projects. That is a reasonable starting point. However, square footage alone is not an adequate measure of a data center's impact. A smaller building can still place extraordinary demands on the electrical grid, use large amounts of water, operate numerous generators, and produce continuous noise. The final regulations should therefore consider electrical demand, water use, generator capacity, acreage, and total campus impact in addition to building size.</p> <p>The regulations should also prevent large developments from being divided into several smaller buildings, phases, parcels, or affiliated projects in order to avoid stricter review. Related facilities that share ownership, utility infrastructure, substations, cooling systems, or a coordinated development plan should be evaluated as one overall campus.</p> <p>Public review should be based on potential community impact, not simply whether a project falls above or below a square-footage threshold. Data centers are unusual industrial uses. They can operate continuously, require major utility upgrades, and have effects that may not be visible from the size of the building alone. Meaningful public notice and review should apply to any project with substantial energy, water, noise, emissions, or infrastructure impacts. Any exemption for an accessory data center should be narrowly defined so that it covers ordinary server rooms, not large commercial facilities placed inside another development.</p> <p>Noise protections should also be strengthened. Data-center noise is not limited to occasional construction or vehicle traffic.</p> |

|  |  | <p>Cooling equipment, transformers, substations, and generators can create continuous low-frequency and tonal noise that is especially disruptive at night. The final ordinance should include separate daytime and nighttime limits, standards for low-frequency noise, pre-construction modeling, post-construction testing, and enforceable monitoring and complaint procedures.</p> <p>Water use is another concern that deserves more than a general preference or recommendation. Applicants should disclose projected daily and peak water demand, cooling technology, wastewater impacts, and drought operations. Louisville should require closed-loop or recycled-water cooling where feasible and should establish reporting requirements so that actual water use can be compared with the projections made during approval.</p> <p>The same principle applies to electricity and utility costs. Developers should be responsible for the infrastructure upgrades required by their projects, and existing residential and business customers should not bear those costs through higher rates. Claims that a project will not burden ratepayers should be supported by independent analysis and appropriate financial guarantees, not only by statements from the applicant. The review should also consider cumulative demand from multiple proposed data centers, not each project in isolation.</p> <p>Louisville should pay particular attention to where these facilities are concentrated. Restricting large data centers to heavy industrial districts may reduce conflicts in some neighborhoods, but it can also place additional burdens on communities that have already experienced decades of industrial pollution, disinvestment, and infrastructure stress. Economic development should not depend on repeatedly asking the same communities to absorb noise, emissions, visual impacts, utility infrastructure, and environmental risk. The final regulations should require a cumulative-impact and environmental-justice review before approving projects in already burdened areas.</p> <p>The ordinance should also establish clear requirements for ongoing compliance. Applicants should provide annual reporting on energy use, water use, generator operation, emissions, noise complaints, and compliance with approval conditions. Metro government should have clear inspection authority, meaningful penalties, and the ability to require corrective action. Projects should also include decommissioning plans and financial assurance so that the public is not left responsible for abandoned equipment or facilities.</p> <p>I do not support a blanket prohibition on data centers. Louisville should be able to benefit from responsible technology investment. But responsible investment requires clear limits, transparency, independent review, public participation, and enforceable protections. The goal should not simply be to prevent the largest individual facility. It should be to ensure that the total scale and location of data-center development remain consistent with Louisville's infrastructure capacity, environmental responsibilities, and obligations to its residents.</p> <p>I encourage Metro government to retain the proposed restrictions on hyperscale facilities while strengthening the ordinance in the following areas:</p> |

Nationally, roughly 40% of data centers are sited in areas already under water stress, and even where a facility uses “closed-loop” or air cooling to reduce direct water use, generating the electricity to power it consumes still more water at the power plant. Louisville has already seen this debate play out with the Camp Ground Road facility near Shively, where developers and Louisville Water Company assured residents supply wouldn’t be affected — but similar assurances in other cities (like Yorkville, Illinois) have been followed by double-digit annual water rate hikes to fund infrastructure upgrades needed to meet data center demand. I don’t want Louisville families paying more for water, or facing use restrictions during droughts or summer heat advisories, so that a data center’s servers can stay cool.</p> <p>2. Data centers strain the power grid and drive up electricity costs.</p> <p>Cooling and running these facilities requires hundreds of megawatts of continuous power. Utilities routinely say the grid can absorb the load, but residents elsewhere have already been asked to cut back electricity use during peak summer demand, even before large new data center loads came online. Adding a massive, constant industrial draw to our grid risks higher rates and less reliability for everyday households, especially during the extreme heat Louisville already experiences.</p> <p>3. Environmental and public health concerns.</p> <p>University of Louisville toxicology experts have warned that the cooling processes for hyperscale data centers can increase both air and water pollution in the surrounding area. Cooling systems also often use chemical additives — anti-corrosion agents, biocides, chlorine compounds — that must be properly treated before any water is discharged back into local waterways. This is a real concern for a city sitting on the Ohio River and for neighborhoods near proposed sites.</p> <p>4. Minimal, uncertain economic benefit relative to the footprint.</p> <p>These facilities generate comparatively few permanent jobs once construction ends, largely automated after being built. Meanwhile, they receive substantial state and local tax breaks (Kentucky’s House Bill 8 exempts qualifying data center equipment from taxes), meaning residents may not see the return promised, even as county infrastructure absorbs the impact.</p> |

|  |  |  | <p>Op-Ed: Louisville Must Embrace Data Centers to Secure Our Economic Future</p> <p>By: Stacy Griggs Co-Founder / Chairman AboutBit</p> <p>Artificial intelligence is reshaping the global economy at a pace not seen since the Industrial Revolution. Louisville now faces a defining choice: embrace the infrastructure that will power this transformation or allow investment, jobs, and tax revenue to flow elsewhere. The proposed moratorium on new hyperscale data centers in Louisville is a mistake. We should reject it and instead welcome these facilities as vital engines of growth, job creation, and technological leadership.</p> <p>Residents are right to ask tough questions about electricity, water use, noise, and land use. Those concerns deserve answers grounded in facts rather than assumptions or inaccurate research. When we examine the evidence, the case for responsibly welcoming data centers becomes compelling. Public concern often centers on electricity use, with critics portraying data centers as villains that drive up rates and strain the grid. This is a myth, as senior policy analyst Kristen Walker of the American Consumer Institute has clearly explained. A Lawrence Berkeley National Lab study found no primary correlation between data centers and rising electricity rates. In some cases, data centers can even help lower rates through their predictable, high-volume demand that supports more efficient grid operations and infrastructure investments. Put more simply, investments in data centers ultimately stabilize and lower power costs by spurring additional investment in power generation (which the US and Kentucky desperately need).</p> <p>Data centers aren't draining resources from Kentucky families; they represent smart economic development. Kentucky's power will fuel AI advancement regardless of location (just look at the new Meta facility in Jeffersonville), but building these centers here keeps the economic benefits local: tax revenue, construction jobs, ongoing operations, and the ancillary businesses that spring up around high-tech infrastructure. They also present the potential for major fiber-optic investments that will dramatically improve local connectivity. Banning hyperscale facilities in Jefferson County just pushes them across the river or to other Kentucky counties smart enough to capitalize on the added tax dollars and economic development. Either way, the power produced in Jefferson County (and surrounding areas) will be used for these types of workloads. Under this proposed ban, the only difference is that Louisville will not benefit.</p> <p>Abundant Resources</p> <p>Unlike many other parts of the country facing water scarcity, Louisville and Kentucky enjoy copious water availability. The state has more miles of navigable waterways than any other except Alaska. The Ohio River alone sees approximately 78 billion gallons of water pass Louisville each day. Even the maximum daily water use of one data center facility — about 5 million gallons — represents only roughly six seconds of the river's daily flow. It is literally a drop in the bucket compared to the vast volume we already allow to flow past us into the Gulf. And new data centers are designed to recirculate water, meaning they use far less water than is quoted in these older studies. Collectively, every datacenter in the US uses about 4% of the water it takes to maintain our golf courses. This natural advantage of abundant water positions us exceptionally well to support data centers, which require some water for cooling, with minimal impact on our resources.</p> |

Kentucky is spending close to ½ billion tax dollars to improve broadband, and these companies will make a similar, if not larger, private investment if we simply welcome them.</p> <p>National and Global Stakes</p> <p>The stakes extend far beyond Louisville. It is an economic imperative for the United States to lead in AI. If we cede ground, China will gladly fill the vacuum, capturing the innovation, investment, and prosperity that will define one of the most important industries of the next 50 years. Data centers are the factories of the AI age. This is not just speculation. The House Energy and Commerce Republicans recently asked the administration to investigate whether China-linked entities and other foreign adversaries are helping fuel opposition to U.S. data center development. MSN recently published a report commissioned by OpenAI that found that “Fake Chinese accounts are reportedly poisoning Americans’ stance on data centers.” At minimum, we should recognize that efforts to delay or block critical AI infrastructure — whatever their intent — will serve the interests of America’s strategic competitors. Data centers are the factories of the AI age. Delaying or blocking them isn’t environmental stewardship; it’s self-sabotage that risks forfeiting American dominance and the jobs, wealth, and security that come with it. AI leadership is increasingly viewed not only as an economic issue but also as a national security priority. The computing infrastructure that powers AI will shape innovation, defense, healthcare, manufacturing, and scientific research for decades.</p> <p>Louisville’s NIMBY Pattern</p> <p>Unfortunately, Louisville has a long and costly history of NIMBY (“Not In My Backyard”) resistance, where vocal minorities stall development that would benefit the broader community. The prolonged fight against Topgolf at Oxmoor is a textbook example: years of legal battles, delays, and uncertainty before the project finally opened in late 2022, depriving the area of earlier economic activity and entertainment options. Yet once built, a quick review of Zillow data for properties closest to the site shows that home values have appreciated by approximately 40-50% since opening, delivering real wealth gains for nearby homeowners and proving that such projects ultimately enhance, rather than harm, local communities.</p> <p>Similar delays plagued the construction of new bridges across the Ohio River, holding back regional connectivity and growth for far too long. This pattern repeats across hundreds of projects. A small group of residents uses processes and complaints to block progress that creates jobs, increases property values, and improves the quality of life for the rest of us. Data centers face the same reflexive opposition today. We cannot allow a small number of opponents to prevent projects that provide broad public benefits.</p> <p>Moving Forward Responsibly</p> |

The next generation of infrastructure is digital. Data centers are not simply warehouses full of computers—they are the factories of the AI economy. If we choose to build them here, Louisville can become a leader in the industries that will define the next fifty years. If we choose not to, those opportunities won't disappear.
