As you know, for 35 years, Southwest Community Ministries (SWCM) has served the Jefferson County zip codes of 40258, 40272 and 40177. Our mission is to unite area businesses, churches, individuals, and groups to meet the basic needs of our neighbors in crisis. We believe in the time-tested axiom of "neighbor helping neighbor". Today we meet the needs of our friends through these important programs and much needed services:

**Food Pantry-** though a partnership with Dare to Care, Kroger's, Meijer's and many other groups, we feed more than 2,000 per month.

**Emergency Assistance-** through partnerships with Louisville Metro Government, LG&E and the Louisville Water Co we help our neighbors stay in their homes and avoid traumatic service disruptions by providing \$10,000 worth of assistance every month.

**Medical Assistance-** through a partnership with Kosair we can now help assist students in need, acquire eye glasses needed to continue their education in the classroom.

**Meals On Wheels-** we are the only group in Southwest Jefferson County that serves two hot meals a day to our neighbors. Each month, we deliver more than 1,200 meals to elderly shut-ins who are in desperate need of nutritious food.

**Education Services-** we partner with our neighboring businesses to offer classes on personal finance, job fairs, smoking cessation, and job readiness, etc.

**Back to School-** provided all necessary school supplies for 400 children in our community.

**Christmas Program-** with the help of generous partners supplied gifts to 400 children who would otherwise not have a holiday to celebrate.

On Saturday, September 28, 2019, our community will come together to celebrate what SWCM has done for our neighbors and sustain our mission into the future at our annual dinner. We hope you will join over 300 of our neighbors on a night that promises to be fun and inspiring. There will be a live band, great food catered by Khalil's, silent & live auction all for a great cause.

Metro Louisville has always been a staunch supporter of our ministries. We thank you for your past support and we thank you for this year continued support.
