Subject: Louisville Downtown Management District / Annual Budget Approval

Good afternoon Chair Dorsey and Vice-Chair Piagentini,

On Oct. 19, your committee hosted the Louisville Downtown Management District ("LDMD") and heard their annual report. The statutes and ordinances governing the LDMD require their annual budget to be approved after a public hearing before the Council. I've attached a resolution that approves the budget for LDMD. The resolution is based on last year's resolution approving LDMD's budget. This process was rolled together last year in one committee hearing, but was not processed that way this time around.

Supposing this meets with your approval and support, Chair Dorsey, I would ask that your office initiate the legislation approving LDMD's budget and delegate the matter to me so that we may meet this coming Monday's deadline. I've addressed this email to Chair Schreck as well. If I may be of any support in coordinating other documents, please let me know.

I believe LDMD's budget will be the same or near the same as was presented on Oct. 19. I'd ask LDMD to provide that exhibit here.
