- Discussion regarding Vision, Mission and Values
- The Office of Youth Development had 40 staff members they were on Neighborhood Boards
- The Office of Youth Development now has 30 staff members
- The Louisville Metro Police Department (LMPD), handles the Trauma Inform Reports when youth or involved in domestic disputes or other involvements
- Defining Youth Development
- Defining Social Justice Youth Development
- 143,000 youth in Metro Louisville
- Discussion regarding Transactional Approach - Discrimination, Limited Transportation, Employment & Income, Education, Limited Access to Food, Discipline, and Housing
- Coalition support, Goodwill Industries - Peer support, Louisville Urban League - Navigation plans connecting youth to local services and resources

- \$1 Million Budget - \$150,000 was contracted out to the three partners and \$50,000 paid to a staff member
- The Peer support is through the contract and three persons were hired by Goodwill
- The Goodwill and Urban League are involved with mental health services
- Discussion regarding volunteers being involved to help with the young people
- The LouieConnect Kiosk will be up in the Community Centers

- Question regarding Metro Council being involved and getting the word out regarding the Office of Youth Development and what they have to offer in their newsletters to their constituents
- The Office of Youth Development has been trying to reach the youth with printed flyers
- COVID-19 has put the youth behind in schooling
- Discussion of how the \$144,000 allocated and \$1 Million Metro Council allocated helped the Office of Youth Development to hire Dr. Castle, salary \$50,000, and with only three staff helpers they have done a great job building the system
