The City of Middletown Commission approved the intent to annex ordinance for the neighborhood known as Beckley Woods at its meeting last night, which was held immediately after the required public hearing. As you know the Beckley Woods Home Owners Association asked to be annexed into the City of Middletown and they collected over 80% signed consents for annexation.


The City of Middletown followed the procedure passed by Louisville Metro Council for annexation proposals. The required public meeting was held last night, after certified notice to all owners in Beckley Woods. I am attaching the following for your review:

1. The Intent to Annex Ordinance.
2. The newspaper notification of public hearing.
3. The Certification Affidavit of the City of Middletown clerk acknowledging service to all affected property owners.
4. The signed consents showing over 80% approval for annexation along with a graphic representation of the physical location of approvals.

5. Surveyor's map of the annexation area.
6. Metes and Bounds description of proposed annexation.

I understand that you will submit this letter and attachments to Metro Council for its consideration. Please, let me know if you need anything else from the City of Middletown. **CITY OF MIDDLETOWN  
ORDINANCE NO. 14-16  
AN ORDINANCE STATING THE INTENTION OF THE CITY  
OF MIDDLETOWN TO ANNEX THE SUBDIVISION KNOWN  
AS BECKLEY WOODS**

WHEREAS, the City of Middletown hereby finds that it serves the public interest of the citizens of the City of Middletown to annex the territory known as Beckley Woods Subdivision, because over 80% the residents living there have signed consents asking to be annexed so they can get city services;

AND WHEREAS, annexing this residential area would be a natural extension of city services such as garbage collection and road maintenance, to area residents who need them and the tax burden in providing such services will not be burdensome to the residents to be annexed,

AND WHEREAS, pursuant to KRS 81A.420 and KRS 67C.111, Middletown is both stating its intention to so annex and also asking the permission of Louisville Metro's to annex,

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF MIDDLETOWN, KENTUCKY,

1. It is hereby found, determined, and declared that;
  - (a) The area to be annexed is contiguous to the current boundaries of the City of Middletown.
  - (b) The area to be annexed is urban in character and completely residential and the City of Middletown can provide the area needed city services including, garbage collection, road maintenance, snow removal and street lighting.
  - (c) More than 75% of the residents in the area to be annexed have signed a consent form asking the City to annex their home.
  - (d) The annexation is a normal extension of residential City services by the City of Middletown, which the City finds is in keeping with the City's mission.
  - (e) The area to be annexed is subject to the KRS 67C.111; which requires the approval of Metro Louisville, prior to the initiation of this Annexation.
  - (f) The City of Middletown has notified each and every resident (via first class, certified mail) of the area to be annexed of its intention to so annex; along with a copy of this ordinance and notification of the tax burden imposed and services to be provided; and of a public hearing on this issue at which public comment was heard and recorded.
  
2. It is the intention of the City of Middletown to annex the territory known as Beckley Woods Subdivision, which territory is more particularly in Record Subdivision Plats filed with the county clerk of Jefferson County, Kentucky:
  - (a) Lots 1 through 63; and Lots 93 through 127, on the attached Plat Book 31; Page 48, in the office of the Clerk of Jefferson County, Kentucky. Exhibit One.

(b) Lots 64 through 71; and Lots 73 through 92; and Lots 117 through 120, on the attached Plat Book 31, Page 49, in the office of the Clerk of Jefferson County, Kentucky. Exhibit Two.

(c) Lots 150 through 163, on the attached Plat Book 32, Page 63, in the office of the Clerk of Jefferson County, Kentucky. Exhibit Three.

(d) Lots 134 through 148, on the attached Plat Book 32, Page 64, in the office of the Clerk of Jefferson County, Kentucky. Exhibit Four.

(e) Lots 128A and Lot 128B, on the attached Minor Plat recorded in Deed Book 5318, Page 240, being a partition of Lot 128, Plat book 31, Page 48, all in the office of the clerk of Jefferson County, Kentucky. Exhibit Five.

3. It is hereby declared to be the intention of the City of Middletown to annex the territory described in (2) above. The City of Middletown Commission hereby officially asks permission from Louisville Metro, pursuant to KRS 67C.11, to so annex this territory.

4. The City Clerk has certified a list of the names and mailing address of each of said resident in the area of the annexation. The Clerk further states that first class mail notice of the public hearing to be held the 21<sup>st</sup>, day of August, 2014 was sent to each person on said list on the 4<sup>th</sup> day of August, 2014; and further that this certification is made part of the records and is attached to this ordinance as Exhibit Six


5. This Ordinance is adopted pursuant to KRS 81A.420.

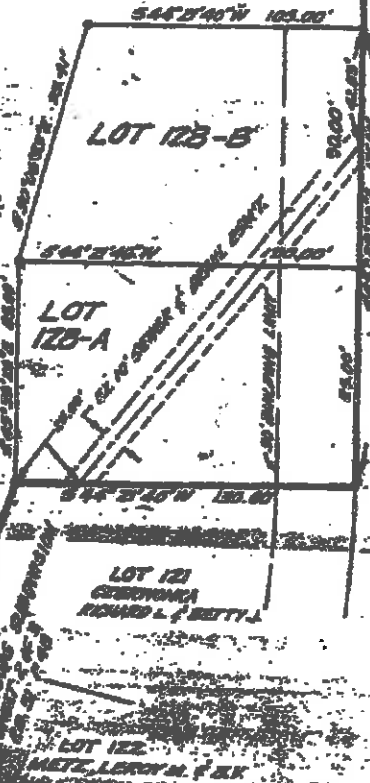




**LOCATION MAP**
