Tim Melton (Manager at LG&E) sent a Death Threat to himself & signed my name as the sender after I told him I was going to report him to his Corporate Office for sending people installing items - to my property only - without ID, refusing to give their names & telling me I could not record them. David Millay (LG&E Security) and Jeremy Livers (Police Officer) and other Police – whom have previously sent 30 Hate/Sexual Degradation/Death threats to me and confessed in writing they sent them - participated in creating the Death Threat Tim Melton sent to himself. I filed a complaint against Jeremy Livers who tried to have me arrested for the complaint that Tim Melton and the police created. Former Chief Conrad denied my complaint and I appealed it to the Merit Board on **June 5, 2020**.

On **July 15, 2021** a meeting was held, in which I was **not** notified. Ms. Dorsey of Human Relations was able to get the meeting rescheduled for **August 25, 2021** and then it was cancelled.

Concern: I have now been told that I have to attend a virtual meeting. I have too much evidence to submit and a virtual meeting would not allow me to hand submit my information.

In that I have been waiting 1 year and 4 months to go before the Merit Board I am requesting that Metro Council assist in me having that right.

- Be advised that the Board cannot impose a penalty or punishment in excess of the action of the Chief . See Kentucky Revised Statutes Section 67C.323

(202B): IT IS FURTHER ORDERED THAT _____, a Qualified Mental Retardation Professional (QMRP), employed at _____, and _____, a Kentucky Licensed Psychiatrist, Psychologist, or Physician with special training and experience in serving individuals with mental retardation, employed at _____, are appointed to examine the Respondent at _____ ("Hospital" or other Facility), and report their findings to this Court within twenty-four (24) hours of the date of examination (excluding weekends and holidays), and that PUBLIC DEFENDER, an Attorney of this Court, is appointed to represent the Respondent. If the above-named Physician is an Authorized Staff Physician of a Hospital, he/she may admit the Respondent to that Hospital pending a Preliminary Hearing if he/she believes that the Respondent should be hospitalized, and further, that Respondent meets the criteria for involuntary hospitalization pursuant to provisions of KRS 202A or KRS 202B. In this case, the Authorized Staff Physician shall notify this Court of the Respondent's admission to said Hospital. The Hospital is authorized to further hold Respondent, who is presently being held under the provisions of 202A or 202B, for purposes of examination by the above-named Physician and/or other Qualified Mental Health/Retardation Professional pending the Preliminary Hearing until released by the above-named Physician or until further order of Court, whichever occurs first.
