PRESIDENT YATES: THE REGULAR LOUISVILLE METRO COUNCIL MEETING OF APRIL 28TH, 2016 WILL PLEASE COME TO ORDER.

[PLEDGE OF ALLEGIANCE].

PRESIDENT YATES: MR. CLERK, A ROLL CALL PLEASE.

MR. CLERK: [ROLL CALL.]

MR. PRESIDENT, YOU HAVE 21 IN ATTENDANCE AND A QUORUM.

PRESIDENT YATES: THANK YOU, MR. CLERK. CAUSE TO RECORD TO REFLECT COUNCIL MEMBER FLOOD AND DOWNARD HAVE EXCUSED ABSENCES.

MR. CLERK: SO NOTED.

PRESIDENT YATES: THANK YOU. BEFORE I GET STARTED, MAY I ASK EVERYONE AT THIS TIME TO PLEASE JOIN ME FOR A MOMENT OF SILENCE IN OBSERVATION OF WORKER'S MEMORIAL DAY. THANK YOU.

ALSO TODAY, THE METRO COUNCIL IS JOINING THE CENTER FOR WOMEN AND FAMILIES. AND A LARGE PERCENTAGE OF OUR POPULATION AND COMMUNITY IN OBSERVATION OF DENIM DAY TO BRING GREATER AWARENESS TO THE PREVENTION OF SEXUAL ASSAULT. I KNOW YESTERDAY WAS TECHNICALLY DENIM DAY BUT TONIGHT IS OUR COUNCIL MEETING. I APPRECIATE THE COUNCILMEMBERS WHO WORE DENIM TODAY IN SOLIDARITY FOR THAT VERY WORTHY CAUSE.

COUNCIL MEMBER TANDY, WILL YOU PLEASE INTRODUCE YOUR PAGE.

COUNCIL MEMBER TANDY: THANK YOU VERY MUCH. COLLEAGUES, WE ARE HONORED TO HAVE WITH US, MR. KANE WATSON. CAN YOU PLEASE STAND UP SO WE CAN SEE THIS FINE YOUNG GENTLEMAN. A 9-YEAR-OLD 4TH GRADER AT SHY ROCK TRADITIONAL ELEMENTARY SCHOOL. RECOGNIZED AS ONE OF THE BE YOUR BEST OUTSTANDING STUDENTS FOR THE THIRD GRADING PERIOD. AS WELL AS EXCEEDING HIS ACCELERATED READER GOAL FOR THE SAME PERIOD. HIS FAVORITE SUBJECT IS SCIENCE AND HE WOULD LIKE TO CREATE VIDEO GAMES OR COUNCILMAN LEET BECOME

AN ENGINEER WHEN HE GROWS UP. KANE ENJOYS PLAYING SOCCER AND BASKETBALL AND READING.

HE ALSO LIKES TO SPEND TIME WITH HIS COUSINS AND HIS FRIENDS. AND IN LIGHT OF THE FACT THAT TODAY IS BRING YOUR SON OR DAUGHTER TO WORK DAY, IT'S ONLY FITTING THAT KANE IS THE PROUD SON OF KELLY WATSON, OUR OWN KELLY WATSON AND DR. KWON WATSON. LADIES AND GENTLEMEN, PLEASE WELCOME MR. KANE WATSON.

[APPLAUSE].

ALL RIGHT, KANE YOU COULD BE SEATED.

MR. PRESIDENT, IF YOU WOULDN'T MIND I WOULD LIKE A POINT OF PERSONAL PRIVILEGE. FOR ALL THOSE IN ATTENDANCE ESPECIALLY THOSE COMING UP TO SPEAK. BY NO MEANS AM I WALKING OUT NOW OUT OF ANY DISRESPECT TO ANYONE SPEAKING. BUT TODAY IS MY WIFE AND MY 15TH WEDDING ANNIVERSARY. AND SO I LOVE THIS CITY. I LOVE THIS COUNCIL. BUT I LOVE MY WIFE A LITTLE BIT MORE.

AND SO, WITH THAT BEING SAID, I WOULD LIKE TO REQUEST AN EXCUSED ABSENCE FOR THE REMAINDER OF THE MEETING.

>> SO NOTED. WOULD YOU PLEASE LET THE RECORD REFLECT AN EXCUSED ABSENCE. I FEEL WE SHOULD DO A MOMENT OF SILENCE FOR COUNCILWOMAN, I MEAN CAROLYN. POOR THING.

PRESIDENT YATES: MR. CLERK, ANY ADDRESSES TO COUNCIL?

MR. CLERK: YES, SIR FIRST SPEAKER IS REVEREND KENNETH GALLOHAR. SECOND MCKENZIE BARRY.

PRESIDENT YATES: MCKENZIE, THANK YOU FOR BEING HERE. BEFORE YOU GET STARTED I JUST WANT TO REMIND EVERYONE WHENEVER THEY ARE ADDRESSING THE COUNCIL TO PLEASE REFRAIN FROM MAKING ANY PROFANITY OR DEROGATORY STATEMENTS AT THE COUNCILMEMBERS. THANK YOU.

MCKENZIE BARRY: IF OUR CITY WERE WHOLE 9TH STREET DIVIDE WOULD BE BROKEN SO ITS SPINE WOULD BECOME LESS BOUNDARY AND MORE BRIDGE. LESS WARNING AND MORE INVITATION. IF OUR CITY WERE WHOLE IT WOULD BE ABLE TO BE CALLED HOME BY ALL IT'S PEOPLE INSTEAD OF TEMPORARY. HAVE WE FORGOTTEN WHAT WE ARE HERE FOR? HAVE WE FORGOTTEN THE BASIC NEEDS OF THE PEOPLE OF LOUISVILLE. IN 2008 IT WAS THE GOAL OF THIS CITY TO INVEST \$10 MILLION ANNUALLY FOR THE AFFORDABLE HOUSING TRUST FUND. OVER THE ENTIRETY OF THE PAST EIGHT YEARS ONLY ONE AND A HALF MILLION DOLLARS HAS BEEN INVESTED IN TOTAL. RIGHT NOW, THERE ARE 21,000 FAMILIES ON THE WAITING LIST FOR AFFORDABLE HOUSING. 21,000 FAMILIES WAITING FOR SAFE, DECENT HOMES THAT THEY CAN AFFORD. 21,000 FAMILIES OF CHILDREN WORKING MOTHERS, SENIORS, VETERANS, PEOPLE WITH DISABILITIES, WONDERING HOW A STANDARD OF DECENCY COULD BE CALLED A HANDOUT.

THESE ARE JUST FAMILIES ON THE WAITING LIST. 92,000 FAMILIES IN LOUISVILLE CAN'T AFFORD THEIR RENT OR MORTGAGE. THERE ARE 6,000 VACANT PROPERTIES IN LOUISVILLE. THIS IS NOT THE ISSUE OF ANYONE DISTRICT. THIS IS THE ISSUE OF THE COLLECTIVE. THERE ARE YOUNG PEOPLE, YOUNG TALENT LEAVING THE CITY, HEAD IN HANDS IN SEARCH OF ACCESS THAT HERE IS AN ACCESSIBLE UNLESS YOUR INCOME IS HIGH ENOUGH TO BE HEARD. I SUPPOSE STATISTICS THAT EXPOSE NEGATIVE CIRCUMSTANCES SOUND ALL THE SAME. BUT HERE'S WHAT'S POSSIBLE. WITH 1% INCREASE IN THE INSURANCE PREMIUM TAX, \$13 MILLION A YEAR WOULD BE GENERATED FOR THE TRUST FUND, ACCORDING TO THE URBAN STUDIES INSTITUTE. BY YEAR FIVE THE CONSTRUCTION OF 750 AFFORDABLE HOUSING UNITS WOULD CREATE 587 JOBS AND BRING AN ADDITIONAL REVENUE OF \$46 MILLION INTO THE COMMUNITY. AFFORDABLE HOUSING WOULD PROPEL ANOTHER INITIATIVE OF THE CITY. 55,000°. RIGHT NOW THERE ARE OVER 6,000 HOMELESS J.P.S. STUDENTS WONDERING HOW THEY COULD ACCESS.

A COLLEGE EDUCATION FROM THE STREETS PAID TO BE PAVED BY THE CITY INSTEAD OF HOMES BEING BUILT. IT'S NOT A MATTER OF FUNDS, BUT RATHER OF PRIORITIES. THE 9TH STREET DIVIDE DOESN'T DISCRIMINATE. THOUGH AFFORDABLE HOUSING IS IN GREATER NEED IN WEST LOUISVILLE, IT'S IN GREAT NEED ACROSS THE CITY AS A WHOLE. HOW IS THERE NO FUNDING FOR HOUSING BUT 139 MILLION OF FUNDING FOR THE OMNI HOTEL, FOR LUXURY APARTMENTS AND HIGH END HOTEL ROOMS. WHAT ARE YOU INVESTING IN? THE PEOPLE OF YOUR CITY OR LUXURY. I'M A SENIOR IN HIGH SCHOOL. A J.P.S. STUDENT. THERE ARE OVER 6,000 OF MY FELLOW STUDENTS IN NEED OF A HOME. WE ARE WAITING FOR THE ACTION IT TAKES FOR OUR CITY TO BECOME CLOSER TO WHOLE. I RESPECTFULLY ASK, WHERE DO YOUR PRIORITIES LIE? [BELL] [APPLAUSE].

MR. CLERK: JALEN POSEY. I APOLOGIZE IF I'VE MISPRONOUNCED YOUR NAME.

JALEN POSEY: IT'S OK. SWARM ABOVE ME PLEASE. I AM MAJESTICALLY WHEN I ASK FOR HELP. I HAVE MY HANDOUT, DESPERATELY. ASKING YOU FOR AN OUNCE OF HOPE. MY HOPE IS SHOT DOWN. ASSASSINATED BY YOU. YOUR EYES ARE WARM BULLETS, PIERCING THROUGH MY SOUL, WHEN I STARVE TO DEATH ON THIS OPEN ROAD THAT'S COLD. THE ONLY SIGHT I SEE IS POLITICIANS CLIMBING MONEY TREES. CONTINUING GENERATIONS OF GENTRIFICATION. DERBY CITY IS LIVING CONFIRMATION THAT THE GREED IS THE SOUL OF THIS NATION. SINGLE MOTHERS CAN'T PAY THEIR BILLS. TOO MANY YOUTH ARE HOMELESS. THE STRUGGLE IS REAL. AND WE ALL KNOW HOPE DON'T PAY THE BILLS. POOR PEOPLE NEVER GET THE MORTGAGE DEALS. MILLIONS OF DOLLARS GO INTO DETRIMENTAL DEVELOPMENTS AGAINST THE PEOPLE'S UNKNOWING WILL.

WE ARE THE FOURTH MOST SEGREGATED CITY THAT PEOPLE IN POWER KNOW THIS BUT CONTINUE IT STILL. IGNORING THE FACT THAT IF THEY WERE RIGHTEOUS IN THEIR JUDGMENT AND ACTS THEY COULD ANSWER THE CALL OF THE CITIZENS SAYING, WE DESPERATELY NEED CHANGE. AND WHENEVER YOU DO SOMETHING YOU

DON'T INTERRUPT THE STATUS QUO, WHICH IS INSANE. DO THE RIGHT THING. USE YOUR POWER TO MAKE A CHANGE.

PRESIDENT YATES: JASMINE FREDERICK?

JASMINE FREDERICK: KIND OF SHORT. PICTURE THIS. A GROWN MAN 47 YEARS STRONG SITTING ON HIS OLD MOTHER'S CHAIR, BLOOD BOILING, SHAME LINGERING ON HIS EXISTENCE. I DIDN'T MEAN TO DO IT, HE SAYS. I WENT TO PRISON FOR TEN YEARS FOR I WAS IN THE WRONG PLACE AT THE WRONG TIME. THE HEIGHT OF THE RIDE OR DIE MOVEMENT. I WAS JUST TRYING TO GO HOME. GUN IN MY HANDS FACE COVERED IN SWEAT, THE POLICE SHOWED UP AND LOOKED INTO MY PAST BEFORE THEY TOOK ME IN. HE WAS A RICH MAN THEY SAY.

WHAT WERE YOU DOING WITH A GUN IN YOUR HANDS THEY ASKED AND THEN I WAS BOOKED. ORANGE SUIT AND CHAINS BECAME MY ADORNMENT. MY 50-YEAR-OLD MOTHER WAS MY ESCAPE OUTLET. SHE LET ME IN BUT AFTER 20 YEARS OF DENIED LOANS SHE GOT SO SICK OF IT. I WANTED A HOUSE BUT I KNEW I COULD NEVER AFFORD IT, SO I BECAME AN ANGRY BLACK MAN. 47 YEARS OLD. DESTROYED PATH WITH NO WAY OUT. I CAN'T GET A JOB BECAUSE I WAS A CONVICTED MAN, RAN OUT OF MONEY BECAUSE I HAD TO PAY BILLS FOR MY MOTHER WHO CAN BARELY GET OUT OF HER OWN BED, TRIED TO KILL MYSELF BUT I COULDN'T BECAUSE MY INSIDES REFUSED TO ACCEPT MY ENDLESS PRIDE. IT WAS A DOMINO EFFECT.

I'M ON MY MOTHER'S COUCH. 47 YEARS OLD, NO HOUSE, NO JOB, NO MONEY, NO HOPE. AND THE STILLNESS IS DEAFENING. MOMMY PLEASE FORGIVE ME. YOUR RECENT DEATH A REMINDER OF THE GREEDY CORRUPT HUMAN BEING THAT'S TOOK EVERYTHING FROM ME. MONEY, MY FAMILY. THEY DENIED ME. CLICK, CLICK, CLICK. THE REVOLVER IN MY HANDS, TURNS, ONE, TWO, THREE. I LOVE YOU MOMMY. BANG. AND THEN DARKNESS. THE STILLNESS IS DEAFENING. I SEE MY HOUSE, MY LOANS TURNED DOWN. THE GREEDY MEN IN GREY CLOTHES TORE OFF MY CROWN. EXCUSE ME, SIR, I SAY TO A MAN WALKING DOWN THIS DARK STREET IN

THE FRAY. DO YOU KNOW WHERE MY HOME IS? WE STOLE IT, HE STATES. WE JUST FIGURED YOU WOULDN'T HAVE ENOUGH MONEY TO PAY, BUT SIR, I SAY I WORKED THREE JOBS DAY BY DAY, STILL MY MOTHER DIED ON THE SAME COUCH I TOOK MY LAST BREATH ON, HERE TO SAY, SORRY. THE MAN FLATLY STATES AND WALKS AWAY, SMIRK ON HIS FACE.

THIS IS A TRUE STORY ABOUT HOW AN AFFORDABLE HOUSING DESTROYED THE MAN OF A JAMAL BROWN. OPEN YOUR EYES PEOPLE AND YOU WILL SEE WHAT IS FORCED UPON YOU TO BE UNSEEN.

MR. CLERK: MR. PRESIDENT, THAT CONCLUDES THE ADDRESS OF THE COUNCIL.

PRESIDENT YATES: THANK YOU, MR. CLERK.

COUNCILMAN DAVID JAMES, DO YOU HAVE A SPECIAL PROCLAMATION FOR US?

COUNCIL MEMBER JAMES: I DO. IF I COULD GET KAITLYN ALLIE. THERE SHE IS. HOW ARE YOU DOING? ALL RIGHT. COLLEAGUES, TODAY IS A VERY SPECIAL DAY. I'M JOINED WITH KAITLYN OF THE UNITED FOOD AND COMMERCIAL WORKERS 227. AND SOME OF HER FRIENDS AND COLLEAGUES ARE HERE TOO, I BELIEVE. COULD YOU STAND UP? WE HAVE THE TEAMSTERS 793 AND TEAMSTERS 89. GREATER LOUISVILLE CENTRAL LABOR COUNCIL IS HERE. C.W.A. A.E.W. MACHINISTS, S.I.E.U. IS HERE. AND A.T.U. IS HERE. I THINK I GOT EVERYBODY, RIGHT?

COUNCIL MEMBER TANDY: E.M.S. IS HERE TOO. SORRY. THANK YOU. THESE ARE THE WORKING MEN AND WOMEN OF OUR COMMUNITIES. AND REPRESENTING THEM. AND TODAY IS WORKER'S MEMORIAL DAY. IN 2015, WE LOST SIX WORKERS HERE IN JEFFERSON COUNTY. I'M GOING TO READ THEIR NAMES, SO WE CAN REMEMBER WHO THEY ARE. KYLE JOHN APPLE GATE. DATE OF DEATH MAY 21ST,

2015. HE WAS A CAR WASH WORKER. LEE HUGO KISCHEKI, DATE OF DEATH, OCTOBER 20TH, 2015, HE WAS A SECURITY GUARD. CHRISTOPHER BRETT COOK. DATE OF HIS DEATH WAS MAY 11TH, 2015. AND HE WAS A FACTORY LABORER. JONATHON PEW, MAY 9TH 2015, WAS A POLICE OFFICER. CORY ROSS, NOVEMBER 14TH, 2015, WAS A PIZZA DELIVERY DRIVER. AND DANIEL ZABBO, OCTOBER 2ND, 2015 WAS A CABLE NETWORK ENGINEER. THEY WORKED HARD FOR OUR COMMUNITY. WORKED HARD FOR THEIR FAMILIES AND THEY LOST THEIR LIVES IN THAT PROCESS.

SO WE HAVE A PROCLAMATION WE WOULD LIKE TO GIVE TO YOU, KAITLYN, TO REPRESENT ALL THE WORKERS. YOU COULD BE VANNA WHITE.

IT SAYS TO WHOM ALL THESE SHALL BECOME GREETINGS. THE COUNCIL HEREBY PROCLAIMS WORKER MEMORIAL DAY.

WHEREAS THE OCCUPATIONAL SAFETY AND HEALTH ACT AND MINE SAFETY AND HEALTH ACT PROMISES WORKERS THE RIGHT TO A SAFE JOB.

AND WHEREAS EACH YEAR THOUSANDS OF WORKERS ARE KILLED AND MILLIONS MORE SUFFER INJURY OR ILLNESS BECAUSE OF THEIR JOBS AND STILL MANY WORKPLACE HAZARDS ARE UNREGULATED.

AND WHEREAS JOB SAFETY CONCERNS ENSURE WORKERS RIGHT TO HAVE A VOICE ON THE JOB, AND IN KENTUCKY ALONE IN 2015 ACCORDING TO PREVENTION AND RESEARCH CENTER AT UNIVERSITY OF KENTUCKY COLLEGE, 81 WERE RECORDED. KENTUCKY OCCUPATIONAL FATALITY RATE WAS 21% ABOVE THE NATIONAL RATE. 30 WORKERS IN TRANSPORTATION MATERIAL MOVING OCCUPATION LOST THEIR LIVES IN KENTUCKY LAST YEAR, AND AS LEAST 17 OF THE 80 WORK-RELATED INVOLVED DRUGS OR ALCOHOL. STRUGGLES IMPROVED WORKING CONDITIONS AND MADE JOBS SAFER.

THEREFORE BE IT RESOLVED THE LOUISVILLE METRO COUNCIL WE PAY TRIBUTE TO OUR WORKERS ON WORKER'S MEMORIAL DAY BY THIS PROCLAMATION WITH ALL RIGHTS, PRIVILEGES AND RESPONSIBILITIES THERE TO PERTAINING. IN TESTIMONY WE CAUSED THESE LETTER TO BE MADE AND SEAL OF LOUISVILLE

GOVERNMENT TO BE MADE THIS 28TH DAY OF APRIL, 2016. THANK YOU, KAITLYN.

[APPLAUSE].

>> I'M A LITTLE SHORTER. COUNCILMAN YATES, THANK YOU VERY MUCH. TODAY THE GROWING FAMILY OF THE GREATER LOUISVILLE CENTRAL COUNCIL IS SO PROUD TO JOIN WITH YOU TO REMEMBER THOSE WHO HAVE SUFFERED OR DIED ON THE JOB. AND TO RENEW OUR FIGHT FOR SAFE AND HEALTHY WORKPLACES. AS THE PROCLAMATION READS, WORKERS AND THEIR UNIONS OVER DECADES OF STRUGGLE HAVE BEEN ABLE TO PASS IMPORTANT LAWS LIKE THE OCCUPATIONAL SAFETY AND HEALTH ACT BUT STILL TOO MANY PEOPLE ARE SUFFERING. THE REALITY IS, WORKPLACE FATALITIES IN THE UNITED STATES ARE INCREASING.

IN 2014, THERE WAS 4,679 PEOPLE WHO LOST THEIR LIVES ON THE JOB. THAT'S ACTUALLY A 2% INCREASE FROM 2013. AND IF YOU LOOK AT SPECIFIC INDUSTRIES THOSE NUMBERS BECOME EVEN MORE ALARMING INCLUDING INDUSTRIES THAT ARE VERY IMPORTANT TO OUR STATE OF KENTUCKY. LIKE MINING. WHICH SAW 17% INCREASE FROM 2013 TO 2014 IN WORKPLACE FATALITIES AND AGRICULTURE WHICH SAW A 14% INCREASE. OUR UNIONS INVEST A LOT OF MONEY IN PROVIDING ADDITIONAL SAFEGUARDS FOR OUR MEMBERS AT WORK. STEWARDS AND UNION REPRESENTATIVES RECEIVE SPECIAL TRAINING THAT ALLOW THEM TO IDENTIFY AND FIX PROBLEMS BEFORE SOMEBODY GETS HURT. WE ALSO PROVIDE ADDITIONAL TRAINING IN THINGS LIKE HANDLING DANGEROUS CHEMICALS AND ERGONOMICS. WE FORM SAFETY COMMITTEES THAT ARE CONSTANTLY ASSESSING RISK AND WE NEGOTIATE ADDITIONAL PROTECTIVE GEAR FOR OUR MEMBERS. THESE ARE THINGS THAT MATTER. AND THEY ARE PART OF THE INCREDIBLE VALUE OUR UNIONS IN THIS ROOM PROVIDE THEIR MEMBERS EACH AND EVERYDAY. OUR COUNTRY IS GROWING, AND OUR LOW INCOME PART-TIME ECONOMY HAS EMBOLDEN SOME EMPLOYERS TO CUT CORNERS PUTTING WORKERS AT RISK. NEW STANDARDS SUCH AS STRONGER PROTECTIONS FOR WHISTLE-BLOWERS WHO SPEAK OUT AGAINST HAZARDOUS CONDITIONS ON THE JOB MUST BE ENFORCED IN ORDER TO KEEP UP WITH A RAPIDLY CHANGING ECONOMY.

BUT THE SIMPLE FACT IS OUR UNION FAMILY HERE TONIGHT IS NOT JUST HERE FOR OUR MEMBERS. BECAUSE WE STAND WITH EVERY HARD-WORKING PERSON THAT WILL FIGHT FOR THEIR RIGHTS INCLUDING THE RIGHT TO REPORT HAZARDOUS WORKPLACES AND RIGHT TO JOIN OUR UNION FOR A SAFE AND HEALTHIER WORKPLACE. EVERY WORKING MAN AND WOMAN DESERVES A SAFE PLACE TO WORK. I WANT TO RECOGNIZE AND ASK THIS COUNCIL, WHEN WE DO HAVE AN INJURY THE BRAVE MEN AND WOMEN WHO ARE E. M.S. PROVIDERS WHO ARE STANDING IN THE BACK OF THE ROOM, TEAMSTERS 783 MEMBERS --

[APPLAUSE]

THEY NEED OUR SUPPORT IN NEGOTIATING A CONTRACT THAT PROVIDES THEM BETTER WAGES, BETTER BENEFITS AND BETTER WORKPLACE STANDARDS AND THEY DESERVE OUR SUPPORT. THANK YOU VERY MUCH AND THANK YOU BOTH FOR THE PROCLAMATION.

PRESIDENT YATES: THANK YOU, EVERYBODY.

MR. CLERK: COUNCIL MEMBER STUCKEL, WOULD YOU PLEASE INTRODUCE YOUR GUEST?

COUNCIL MEMBER STUCKEL: PRESIDENT YATES AND COLLEAGUES AND THE VIEWING PUBLIC, I HAVE THE PRIVILEGE AND PLEASURE OF INTRODUCING YOU TO A VERY FAMOUS LOUISVILLIAN. ONE OF MY CONSTITUENTS, THE SON OF MY CONSTITUENTS, IF HE LOOKS FAMILIAR YOU PROBABLY SAW HIS PICTURE AND HIS PARENT'S PICTURE ON THE FRONT OF "THE COURIER" ABOUT TWO WEEKS AGO. ALL RIGHT? THIS IS EMMANUEL BLAKE DAWSON AND HIS PARENTS, OPAL AND GREG DAWSON AND I DON'T KNOW YOUR SISTER'S NAME. WHO IS THE YOUNG LADY? YOUR GIRLFRIEND.

>> YOU ARE GOING TO GET HIM IN TROUBLE.

COUNCIL MEMBER STUCKEL: I WILL READ THIS. WHEREAS BLAKE IS GRADUATING FROM BROWN SCHOOL WITH A 4.26 GRADE POINT AVERAGE, AND WHEREAS BLAKE HAS FILLED OUT APPLICATIONS, SAT FOR INTERVIEWS AND TYPED NUMEROUS

ESSAYS TO ACHIEVE HIS GOAL OF LEAVING COLLEGE DEBT-FREE. AND WHEREAS
BLAKE HAS EARNED MORE THAN \$1 MILLION IN SCHOLARSHIPS FROM ORGANIZATIONS
SUCH AS BROWN FORMAN AND UNIVERSITIES LIKE THE UNIVERSITY OF LOUISVILLE
AND FISK UNIVERSITY, WHERE HE HAS BEEN OFFERED FULL RIDES. AND WHEREAS

PRESIDENT YATES: MAY I HAVE A MOTION AND SECOND FOR APPROVAL?

>> SO MOVED.

>> SECOND.

PRESIDENT YATES: THE ORDINANCE BEFORE US. ANY DISCUSSION?
THIS CAME OUT OF THE PLANNING ZONING COMMITTEE. I WILL FIRST DEFER TO
COUNCILMAN STUCKEL. WOULD YOU LIKE THE FLOOR?

COUNCIL MEMBER STUCKEL: THANK YOU, PRESIDENT. THIS PROPERTY IS
AT THE CORNER OF BROADWAY AND BAXTER AVENUE ACROSS FROM CAVE HILL
CEMETERY. PROPOSED USE IS MIXED USE COMMERCIAL RESIDENTIAL. THERE WOULD
BE 281 APARTMENT UNITS AND 33,000 SQUARE FEET OF RETAIL SPACE. MOST OF
THE BUILDINGS WOULD BE FOUR STORY. THIS PROPERTY ALSO INCLUDES THE
SECTION THAT WAS ONCE THE PHOENIX HILL TAVERN. I KNOW A BUNCH OF YOU
PEOPLE HAVE SPENT SOME TIME THERE. THERE IS AN INTERNAL PARKING GARAGE
WITH ABOUT 150 SPACES. I MIGHT ADD PARKING WAS AN ISSUE DISCUSSED QUITE A
BIT IN COMMITTEE. REQUEST INCLUDES TWO VARIANCES REGARDING BUILDING
HEIGHT AND DISTANCE FROM RIGHT OF WAY LINES. ONE WAIVER ELIMINATING THE
BUFFER AND PLANNINGS BETWEEN C- 2 AND C-R.

A PUBLIC HEARING WAS HELD ON MARCH 17TH, 2016. ONE PERSON SPOKE
IN OPPOSITION. THOUGH A FEW OTHERS DID HAVE CRITICISM AT THE OVERLAY
DISTRICT MEETING. THE PLANNING COMMISSION APPROVED THIS REQUEST
UNANIMOUSLY. OUR PLANNING AND ZONING COMMITTEE VOTED 5 FOR APPROVAL AND 1
PERSON, MR. ACKERSON VOTED PRESENT. THIS IS IN COUNCILMAN TANDY'S
DISTRICT. HE HAS LEFT FOR THE EVENING. BUT COUNCILMAN OWEN IS VERY
FAMILIAR WITH THIS IN THE DISTRICT RIGHT ADJACENT. HE WILL PROBABLY MAKE
A COMMENT. THANK YOU.

PRESIDENT YATES: COUNCILMAN?

COUNCIL MEMBER OWEN: BRIEFLY, JUST TO SAY THAT A DEVELOPMENT
COMPANY HAS TWO PROJECTS. CURRENTLY IN MR. TANDY'S DISTRICT BUT AWFULLY
CLOSE TO MY DISTRICT. THE ONE IS ON THE OLD MERCY ACADEMY SITE AND THE
OTHER IS ON A SITE THAT INCLUDES THE OLD PHOENIX HILL TAVERN. THERE HAS

BEEN SUBSTANTIAL AMOUNT OF REVIEW ESPECIALLY ON THE ONE THAT IS BEING CONSIDERED FOR REZONING TONIGHT. INCLUDED A SIGNIFICANT REVIEW OF BOTH THE CONSTRUCTION MATERIALS AND THE DESIGN THAT WENT BEFORE THE BAXTER BARGE TOWN ROAD OVERLAY DISTRICT. AND THAT WAS A VERY, VERY LENGTHY PROCESS. SO THESE ARE VERY HOPEFUL PROJECTS. AND I WOULD ENCOURAGE PASSAGE OF THIS ZONING FOR THAT ONE SITE TONIGHT.

PRESIDENT YATES: THANK YOU.

COUNCILMAN ACKERSON.

COUNCIL MEMBER ACKERSON: THANK YOU, MR. PRESIDENT. AS COUNCILMAN STUCKEL TALKED ABOUT, THERE WAS QUITE A BIT OF DISCUSSION ABOUT PARKING. THIS IS AN AREA WE HAVE SEEN NUMEROUS NEWSPAPER ARTICLES TALKING ABOUT THE PROBLEMS WITH PARKING IN THE HIGHLANDS, BARGE TOWN ROAD AND BAXTER AVENUE CORRIDORS. THEY WERE SEEKING \$10 MILLION IN CITY SUBSIDIES TO HELP THEM PAY FOR A PARKING GARAGE. THAT NUMBER IS COMING IN ABOUT \$7 MILLION IS MY UNDERSTANDING. SO THERE'S A \$3 MILLION DIFFERENCE IN WHAT THEY WERE INITIALLY PLANNING TO DO AND WHAT'S BEING OFFERED NOW. MY CONCERN OVER PARKING IS THIS, THE NUMBER OF UNITS THAT ARE IN THERE, ADDITIONALLY THERE IS RETAIL SPACE. THE NUMBER OF UNITS ARE GOING TO BOIL DOWN TO APPROXIMATELY 1.5 SCHEDULED AS NOW, 1.5 PARKING SPACES PER UNIT. WE ALL KNOW THE REALITY WE LIVE IN TWO-CAR HOUSEHOLDS TODAY. PARKING WILL BE A CONCERN.

MY CONCERN IS ALSO THE DEVELOPMENT PLAN CHANGE NOW THAT THERE ARE \$3 MILLION LESS IN FUNDING, POTENTIALLY. AS SUCH I HAVE AN AMENDMENT THAT'S BEEN WORKED OUT. MR. WOODY IS HERE. ALSO IF THERE ARE ANY QUESTIONS, HE HELPED ME DRAFT IT UP, DISCUSSING WITH. ON THE SECOND WHEREAS, THE LAST PERIOD WILL CHANGE TO A COMMA AND WILL READ ALONG WITH ADDITIONAL BINDING ELEMENT NUMBER 10 SET FORTH BELOW, SEMICOLON. ON SECTION ONE, THE LAST SENTENCE, THE PERIOD WILL CHANGE TO A COMMA AND WILL

READ, WITH ADDITIONAL LANGUAGE AS WELL AS TO THE FOLLOWING ADDITIONAL BINDING ELEMENT, COLON. AND WE ARE GOING TO ADD 10. THAT LANGUAGE WILL READ ANY AMENDMENTS PROPOSED TO THE DEVELOPMENT PLAN FOR THE SUBJECT DEVELOPMENT SITE, WHICH WAS PRESENTED TO THE PLANNING COMMISSION ON MARCH 17, 2016, WHICH REDUCE PARKING AS OPPOSED WITH APPROVED DEVELOPMENT PLAN GREATER THAN 10% SHALL RECEIVE FINAL APPROVAL BY THE METRO COUNCIL.

ESSENTIALLY WHAT THIS IS DOING, IT SAYS IF THE DEVELOPER, OR ANY SUBSEQUENT DEVELOPER, WHO COMES ALONG, IF THEY CHOOSE TO REDUCE PARKING BY GREATER THAN 10% OF WHAT THEY PROPOSED THEY HAVE TO COME BACK AND GET PERMISSION TO DO THAT. IT'S IMPORTANT TO PROTECT THE INTEGRITY OF THE AREA. AS FAR AS I'M CONCERNED. BARGE TOWN, BAXTER CORRIDOR WITH THE GARDEN DISTRICT TO NEW ORLEANS, BARGE TOWN AND BAXTER TO THIS CITY, SOMETHING WE NEED TO PROTECT. WE NEED TO BE MINDFUL OF THE PARKING FIASCO WE HAVE ALREADY CREATED THERE. SO I HOPE YOU WILL SUPPORT ME IN THIS AND I WOULD LOOK FOR A SECOND IN THAT AMENDMENT.

PRESIDENT YATES: IT'S BEEN PROPERLY MOVED AND SECONDED. ANY FURTHER DISCUSSION ON THIS?

>> THANK YOU, I'M FOR THE AMENDMENT. I GUESS I JUST HAVE A QUESTION, COMMENT. I'M NOT SURE WHERE TO GO, THERE'S A LOT OF ATTORNEYS IN THE ROOM WHO MAY WANT TO ANSWER. IF WE HAVE BEEN GIVING THEM \$7 MILLION AND IT'S BEEN AN ISSUE, THIS WHOLE CORRIDOR ALONG WITH EVEN FRANKFURT AVENUE WHICH DIDN'T HAVE ANYTHING TO DO WITH THIS SITE BUT MAYBE ANOTHER LATER ON BUT IF WE ARE GIVING THEM THIS MONEY AND NOT KNOWING HOW MANY STORIES THEIR PARKING GARAGE IS, WHY AREN'T WE SAYING WE WILL PUT THREE MORE FLOORS ON AND THAT WILL BE PUBLIC PARKING. WE HAVE ADDITIONAL PARKING FOR THE NEIGHBORHOOD. I MEAN, HECK, WE ARE GIVING THEM MONEY. IT'S NOT LIKE THEY CAN SAY WE CAN DO THIS ON THE END. THAT'S WHAT YOU BUILT ELSEWHERE. WHEN YOU ASK FOR MONEY SEEMS LIKE WE HAVE LEVERAGE. I

DON'T KNOW WHY YOU AREN'T USING THAT TO SOLVE, WHAT IS A HUGE PROBLEM. THEIR PARKING DESIGN PROBLEM MIGHT BE THIS, BUT IF WE ARE KICKING IN SOME SKIN, WHY? PUT IN 105 SPOTS FOR US, WALK TO WICKS, AND 426 AND VOLLEYBALL DIRECTION AND SO ON. I DON'T KNOW WHY I KNOW THAT BECAUSE I NEVER GO TO ANY OF THOSE PLACES. BUT ANYWAY. AGAIN, IS IT A LEGALITY ISSUE? DO WE NOT HAVE ENOUGH NERVE? I CAN'T BE THE ONLY GUY SAYING THAT'S A GOOD IDEA. I'M CURIOUS MYSELF.

>> MR. WOODY?

PAUL WOODY: PAUL WOODY, JEFFERSON COUNTY ATTORNEY'S OFFICE. I DON'T THINK IT'S A LEGALITY ISSUE. IT'S BEEN VETTED THROUGH THE NORMAL PROCESS. THAT KIND OF REQUEST COULD HAVE BEEN MADE, CERTAINLY. AND COULD STILL BE MADE. BECAUSE I THINK YOU ARE WITHIN THE 90-DAY PERIOD IF YOU WERE TO TABLE THIS CASE FOR ANY ATTEMPT TO IMPOSE THAT KIND OF RESTRICTION, YOU WOULD BE WITHIN YOUR RIGHT TO DO THAT AND YOU HAVE TIME TO DO THAT. BUT IT, PERHAPS A LITTLE LATE IN THE GAME.

>> I'M SORRY.

PAUL WOODY: I'M NOT INSINUATING IT HAS TO COME NOW. AT SOME POINT SOMEBODY WILL HAVE TO APPROVE A LOT OF MONEY TO GO TO THEM. I'M SAYING MAYBE WE COULD DO IT THEN. AGAIN, WE HAVE A PROBLEM THAT HAS BEEN PUT IN THE NEWSPAPER, TALKED ABOUT PUBLICLY AND WE HAVE SOMEONE WHO IS ALMOST PRESENTING US WITH A SOLUTION. AND I'M JUST CURIOUS WHY WE AREN'T UTILIZING THAT.

PRESIDENT YATES: THANK YOU, COUNCILMAN. BEFORE US, OBVIOUSLY WE HAVE THE AMENDMENT ON THE ORIGINAL ORDINANCE, AND THIS ONLY HAS TO DO WITH THE ZONING TODAY. DO I HAVE ANY DISCUSSION ON THE ACKERSON AMENDMENT TO THIS ORDINANCE? SEEING NO OTHER DISCUSSION. ALL IN FAVOR? THOSE OPPOSED? THE AYE'S HAVE IT. ANY OTHER DISCUSSION ON THE TOTAL ORDINANCE.

PRESIDENT YATES: \$500 FROM DISTRICT 17. MAY I HAVE A MOTION AND SECOND FOR THE ORDINANCE BEFORE US. PROPERLY MOVED AND SECONDED. COUNCILMAN STUCKEL YOU SAID \$500. THANK YOU.

PRESIDENT YATES: COUNCILWOMAN LEET?

COUNCIL MEMBER LEET: DISTRICT 7 WOULD LIKE TO ADD \$500.

PRESIDENT YATES: COUNCILWOMAN SHANKLIN.

COUNCIL MEMBER SHANKLIN: DISTRICT 2 WOULD LIKE TO GIVE \$250.

COUNCILMAN JOHNSON.

COUNCIL MEMBER JOHNSON: \$250 FROM DISTRICT 21.

PRESIDENT YATES: MR. CLERK, COULD YOU GIVE US A NEW TOTAL.

MR. CLERK: \$2,950 THAT WAS AMENDED. ADDED TO THE TOTAL. AND THAT WOULD BE \$15,850. IS THE NEW TOTAL.

PRESIDENT YATES: MAY I HAVE A MOTION AND SECOND FOR THAT AMENDMENT?

PRESIDENT YATES: SEEING NO ONE ELSE LOOKING FOR RECOGNITION?
THERE WE GO. COUNCILWOMAN WELCH.

COUNCIL MEMBER WELCH: THIS ALSO INCLUDES A SECOND EVENT WHICH
WILL BE THE THIRD SOUTH LOUISVILLE BUY LOCAL FAIR THAT WILL BE AT THE
AMPHITHEATRE ON JULY 9TH. TENTATIVELY 6:00 P.M. WHICH IS BEFORE THE

AS IF THERE'S NOT ENOUGH TO DO ALREADY. SUNDAY MAY 1ST AT 6:00 P.M. IN TYLER PARK. KENTUCKY SHAKESPEARE WILL PRESENT "ROMEO AND JULIET" YOU KNOW WHEN I SAY THESE THINGS, THERE'S A THREAT OF RAIN ON BOTH DAYS. IT MAY NOT BE PERFECT.
