Beginning at a point on the northwesterly right-of-way of Old Henry Road and the southeasterly corner of a tract belonging to Old Henry Healthcare 1 LLC. by Deed Book 9210, Page 496 of record in the Office of the Jefferson County Clerk located in Louisville, Kentucky; thence leaving the Old Henry Road right-of-way with a property line common with Old Henry Healthcare 1 LLC. **N 24°52'37" W 92.83 feet** to a point; with a curve to the left with a **radius of 410.00 feet** and a chord with a bearing and distance of **N 08°14'13" W 234.82 feet**; thence **N 08°24'12" 175.86 feet**; thence to the centerline of Wickham Green Way, an existing 50 ft. Public Utility, Sewer and Drainage and Private Access Easement granted by Plat Book 52, Page 94 in the aforementioned Jefferson County Clerk's Office thence with the centerline with a curve with a **radius of 400.00 feet** and a chord with a bearing and distance of **S 74°01'32" E 26.20 feet** to a point on said centerline; thence continuing with said centerline with a curve to the right with a **radius of 726.00 feet** and a chord with a bearing and distance of **S 85°27'30" E 334.26 feet**; thence leaving the Wickham Green Way centerline to the centerline of James Thornton Way, an existing 80 ft. 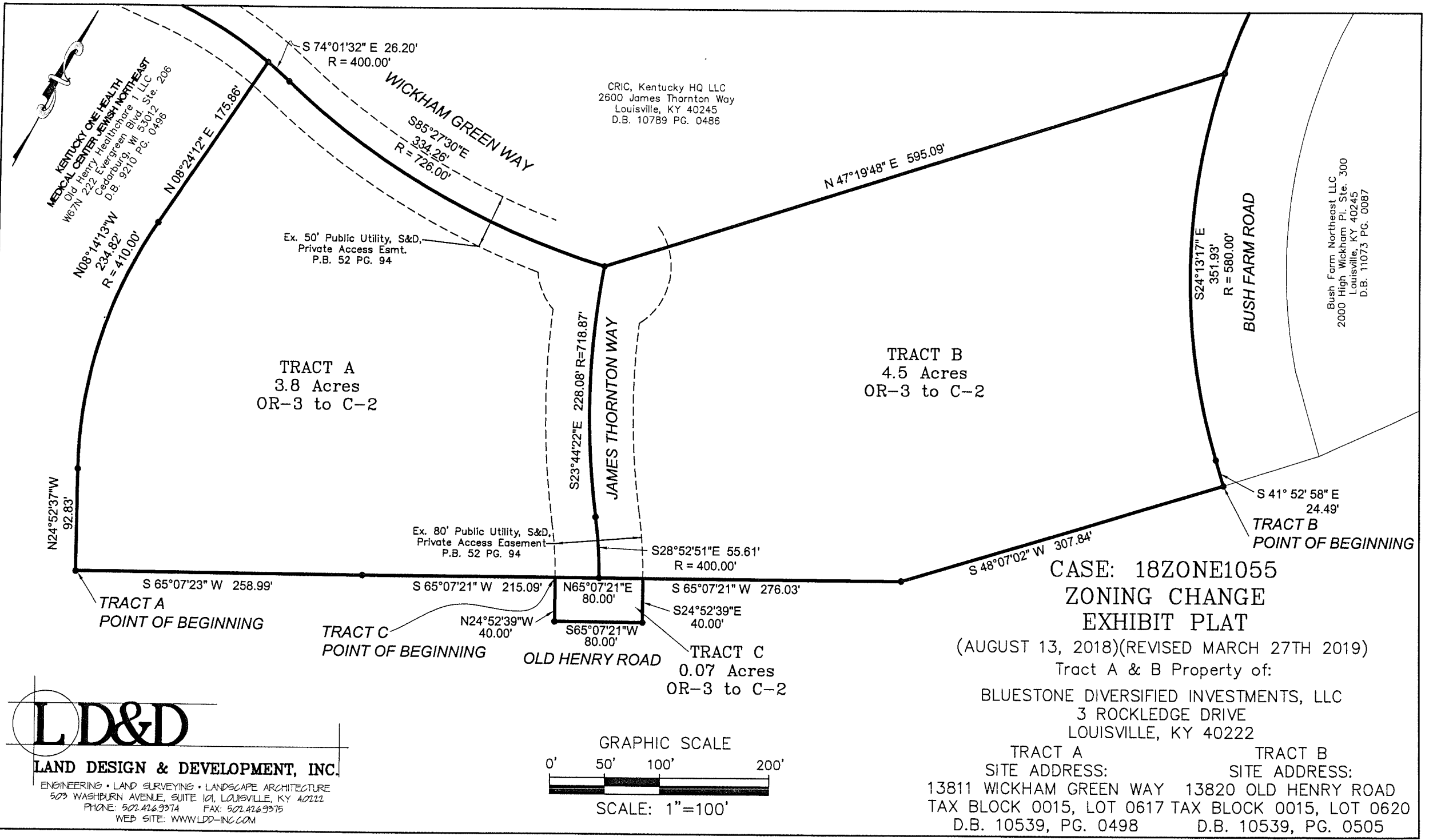
