A motion was made by Committee Member George, seconded by Vice Chair Engel, that this Ordinance be amended as follows:

Add Section 131.11(A)(2) as follows:

"2. Place a sign in clear public view at or near the display of such products stating: 'Graffiti is against the law. Any person who defaces real or personal property with paint or any other liquid or device is guilty of a crime subject to jail time, criminal fines and civil penalties.'"

The following was discussed:

- What the requirements are on purchasing spray paint and any other etching material
- Who would be punished for the violations
- Rewards for turning in someone that has vandalized property
- Age limits on purchasing spray paint
- Signage and control around spray paint in the stores
- Whether spray paint would need to be locked in cages
- Penalty if sign is not posted, civil offense enforced by Code Enforcement Board and in the amount of \$250-\$500

The motion to amend carried by the following vote.

**No:** 2 - McCraney, and Benson

A motion was made by Committee Member George, seconded by Committee Member Hollander, that this Ordinance be amended by:

-Amending Section 131.16 to amend the following sentence as follows:  
"If the person fails to respond to the citation within seven days as referenced above, the person shall be deemed to have waived the right to a hearing and the determination that a violation was committed shall be considered final. In this event, the citation as issued shall be deemed a final order determining that the violation was committed and imposing the civil fine as set forth in the citation, and the person shall be deemed to have waived the right to appeal the final order to Jefferson District Court."

-In Section 131.16, delete the following sentence:  
"In this event, the Board shall enter a final order determining that the violation was committed and impose the maximum civil penalty as set forth in the citation;"

This following was discussed:

- The Code Board handles the punishment
- The punishment is for the person who vandalizes the property
- The language in the Ordinance states that if people do not appeal, this would be a final order and they would not have to go before the Code Board again.
- Property Maintenance does give the property owner time to repair their property before it goes to a citation
