

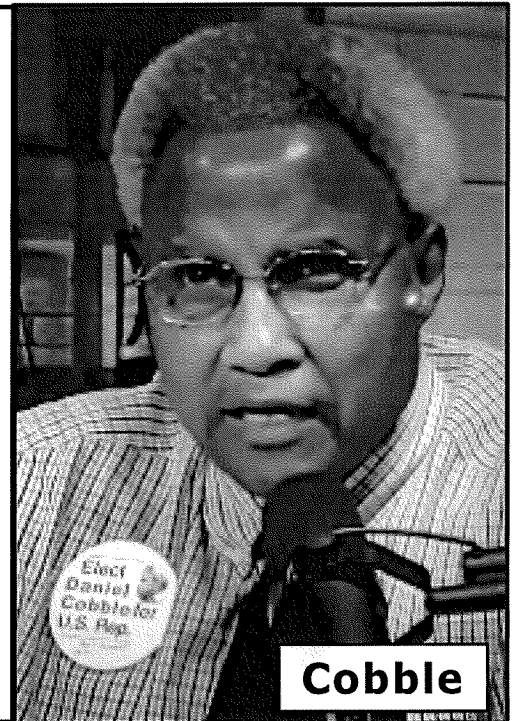
David Yates May Disqualify as County Clerk

A high stakes election for Jefferson County voters. They must choose “corruption as usual” or Mr. Cobble’s agenda for reversing bad and unlawful policies.



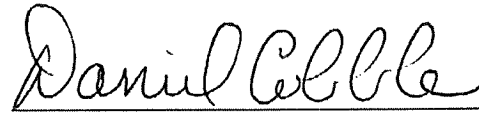

Next, one of the Mayoral candidates says the Mayor Greenberg camp is claiming Greenberg has an 80% approval rating. This is not possible and exemplifies my concern that Clerk Yates will cheat to get Greenberg back in office. His office is no longer taking phone calls that are directed to 311 City Call, and he stopped the tradition of people dropping off information to the Mayor’s office. Thus, he is confident he will get back in.

The Office of Infrastructure: And finally, as you know on April 3, the KY legislature approved \$1 billion to Mayor Greenberg on top of the \$1.6 billion budget that you approved. Shortly afterwards, misappropriations of the \$1 billion began. One is

the \$500,000 for reducing crime. For, Gov't knows well it's the absence of fathers that leads to crime and yet you won't promote fatherhood. That's why if I make it to Washington, I will push for the **Office of Infrastructure (OI)** at the three level of gov't. 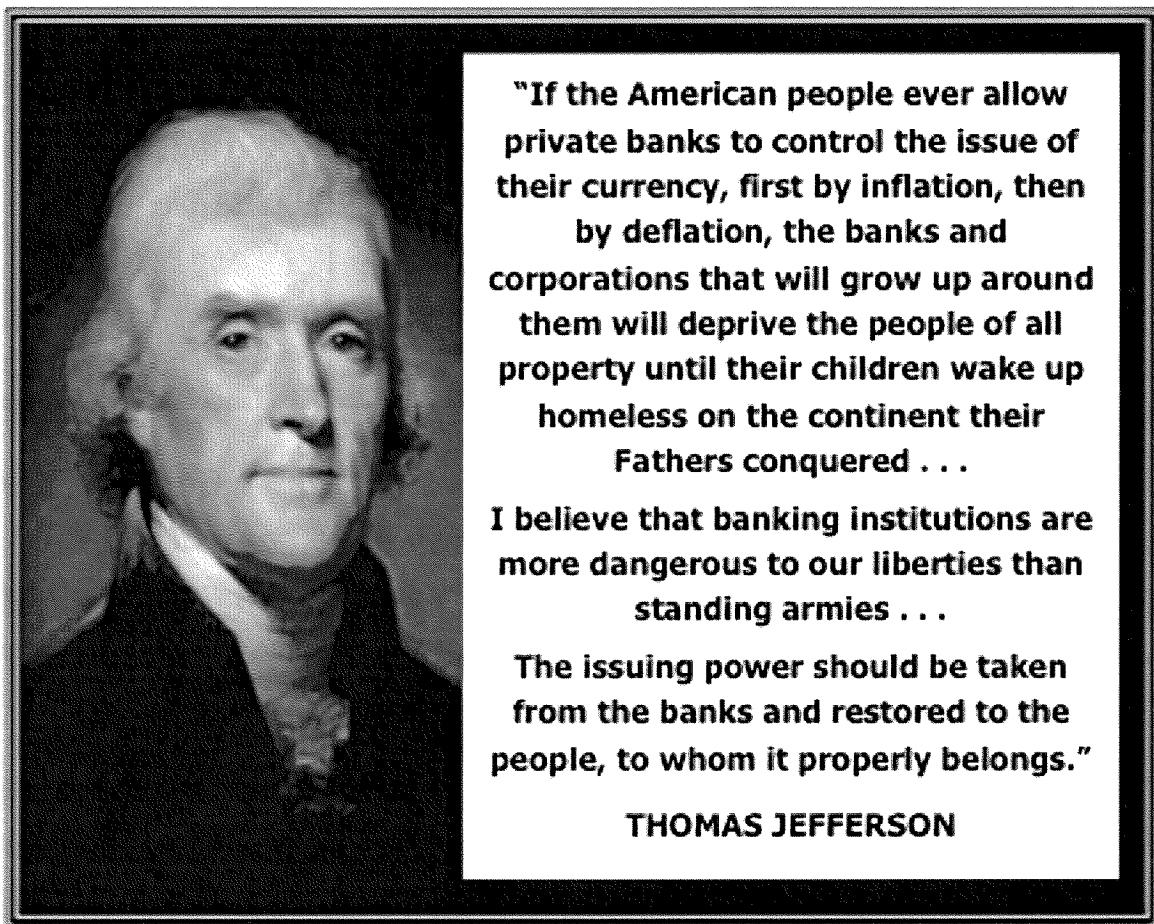

• **MOTION FOR EARLY VOTING TO ENFORCE §147 & §148 OF KY CONST.**

– County Clerk David Yates is ignoring the March 26, 2026 letter of instructions for §148; any election fraud disqualifies Yates for the May 19 election for County Clerk –

– Young voters in Jefferson County want fair & legal elections –

A. §148 bars County & State personnel from operating elections –

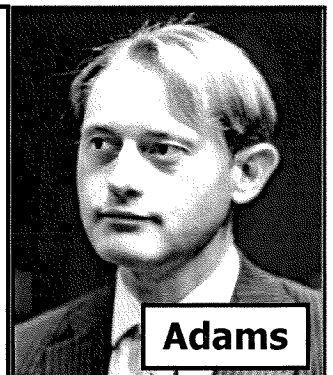
B. Early voting & mail-in ballots must remain sealed until delivered to the Precinct Captain in the precinct where the voters live –

1. Now comes Plaintiff Daniel Cobble to give Notice that County Clerk David Yates is disqualifying himself for “elected County Clerk” in the 2026 primary election. Yates is currently the “interim” County Clerk (unelected & temporary) running in the May 19, 2026 primary election to become the “elected” County Clerk.

2. **Background.** Mr. Cobble filed this lawsuit on Sept. 29, 2023 to resolve the continuing problems with voting in Kentucky that disenfranchises the voters. In recent years, the

Secretary of State and Jefferson County clerks have not enforced §147 and §148 of the Kentucky Constitution. Provision §147 requires all ballots to remain private so that gov’t officials shall not know who is casting the ballot. However mail-in ballots are not kept private as the current election process

informs gov't officials of the identity of the voter casting the mail-in ballot. Then, §148 requires all election officers (**poll workers**) to only operate the precinct where they live, their residence. And thus, §148 bars county & State officials from conducting elections. But this is not occurring; **the current structure of early voting** allows precinct officers to work outside their precincts of residence, and county and State officials join in conducting the elections. — §148's requirement of voting only within the voter's precinct of residence facilitates fast and accurate audits of elections. **Proper and timely audits are not possible when voters vote outside their precincts.**

3. To wit, §148 so states:

“ . . . all officers of any election shall be residents and voters in the precinct in which they act (operate).”

4. **Purpose.** The purpose of Provisions §147 and §148 is to **prevent conflicts-of-interest between voters and gov't officials.** **For example,** Mr. Cobble charges in this lawsuit that Gov't officials cheated in the 2022 election cycle (and in 2024) that disenfranchised voters. Gov't officials have an interest in cheating to get re-elected. **Today,** Mr. Cobble charges that Metro Louisville is conducting unlawful taxation and illegal confidential business practices that prevents tending to the needs of citizens.

5. **Attachment 1** is the county clerk's list of early voting locations that violate §148. **1)** Clerk Yates is allowing voters to vote outside their precincts, and **2)** county and State officials will join in conducting the early elections. **Attachment 2** is Mr. Cobble's March 28, 2026 “instruction letter” to Clerk Yates. The few early voting locations (twenty-four) is self-evident that Clerk Yates intends for county and State officials to count the votes, an illegal and material conflict-of-interest. And whereby, **Mr. Cobble demands\motions for counting votes** the instruction letter's “interim remedy” of keeping all ballots sealed during Early Voting until delivered to- and opened by the Precinct Captain on Election Day of the precincts of the respective residences of voters.

**• §148 OF KY CONST. REQUIRES PRECINCT OFFICERS TO WORK IN THEIR
PRECINCTS & BARS COUNTY & STATE OFFICIALS AS PRECINCT OFFICERS -**

Dear Clerk Yates and Chairmen Fitzpatrick & Gatti,

Please correct Clerk Yates' flyer information (**attached & marked-up**) that incorrectly specifies that **poll workers (precinct officers)** can work outside the precincts where they live. But to the contrary, **§148 of the KY Const.** states that precinct officers can only work **in** the precinct where they live.

To wit, §148 so states:

“... all officers of any election shall be residents and voters in the precinct in which they act (operate).”

County and State officials are not allowed to handle\count the votes. And, of course, §148 implies that voters must vote within their precinct of residence; they cannot vote outside their precincts. (**Voting in your precinct ensures prompt and accurate audits of vote counts.**)

§148 also implies that **mail-in** and **early-voting ballots** must remain sealed\un-open until delivered to their **precinct of residence** on Election Day, to be opened by the Precinct Captain.



§148 of the KY Constitution (1891) requires only precinct officers (poll workers) to conduct elections that live in the precinct that they operate. **To prevent conflicts-of-interest,** county and State officials are not allowed to handle\count votes.

With your office paying \$299 per day, the solution to having enough precinct officers is to summon the registered voters as needed that reside in the respective precincts; the same county clerk summoning powers for jury duty.

• **The significance of 1974 KRS 117.055 for precinct officers**

Clerk Yates, as you well know in accordance with 1974 KRS 117.055, you must divide Jefferson County into precincts with no more than 700 registered voters per precinct. This low amount is necessary for resident precinct officers to have the vote counts ready on Election Night. **KRS 117.055 (1974) so states:**

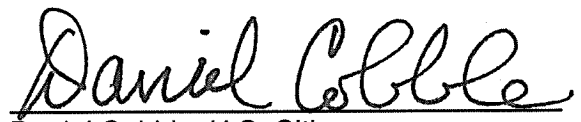
“Each precinct shall contain, as nearly as practicable, an equal number of voters, based on the number of registered voters in the county, not to exceed seven hundred (700) to a precinct.”

And as you well know, the KY State legislature has tampered with KRS 117.055 that no longer enables the operation KY Const. §148. 2024 is the latest amendment to distort 117.055. **So for 2026**, please apply the simple 1974 version for the required 1,168 precincts in Jefferson County so that precinct officers residing in their precincts only have 700 votes to count on Election Night.

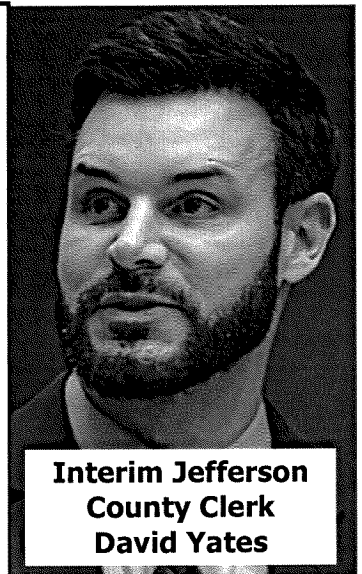
In summary: 1) Precinct officers\poll workers must work within their precincts of residence. 2) All voters must vote within their respective precincts of residence; they cannot vote outside their precincts. And thus, 3) **to prevent conflicts-of-interest**, KY Const. §148 bars county and State officials\personnel from conducting elections. 4) Mail-in and early-voting ballots are to remain sealed until delivered to the Precinct Captain on Election Day in the precinct where the voter resides\lives. 5) En-sure the county is divided into precincts with no more than 700 registered voters per precinct. And 6) summon the election officers needed for Election Day.

Gentlemen, your assistance in this matter is most appreciated. Feel free to contact me with any concerns. **Please conduct the 2026 elections as the bona fide Democracy that we promote to the world at-large.** Let The People's majority prevail.

Next, **on its face**, the \$189 million JCPS budget shortfall is **a criminal cover-up** that began when Marty Polio was superintendent. **It requires a combined audit** by State Auditor Allison Ball and an independent CPA.

And finally, if elected U.S. Representative in November, I will put forth a restructuring plan for JCPS. It will be much lower cost and guaranteed success for each school by being **parent-teacher centric**. It will eliminate the intentionally high cost of the administratively "top-heavy" system that you operate today.

– So voters can identify candidates on ballots, the BCO will require all local broadcasters to broadcast all “locally registered candidates” (including write-in candidates).

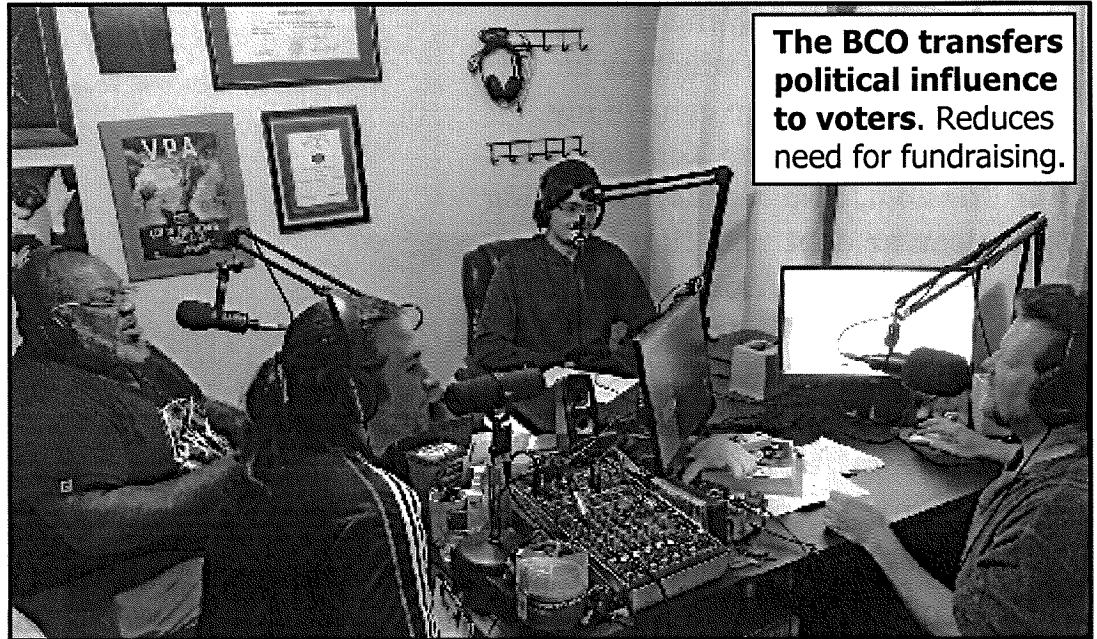
The frustrations of not knowing the candidates

As usual, Cobble's argument to the Court is simple. Without a BCO, we do not have functioning democracy. The BCO idea came in 2022 when the Cobbles could not vote for judges in the general election. They did not know the names of

most on the ballot, and only saw the yard signs of others. Except for community town halls, most candidates cannot get the media exposure for voters to learn their agendas. Voters are left with guessing **or not** choosing a candidate for the particular office. **Again, this is not democracy.**

Whereby, a BCO is a “standing emergency court order” to the **FCC** (Federal Communication Commission) requiring all local radio and TV stations to broadcast all “registered local candidates” running for office (inclu. write-ins). They must broadcast each candidate for at-least 30 minutes, individually, or a maximum group of three. **The legal premise:** The public\ voters have the right to learn all candidates to make informed decisions when voting. And since the public owns the public airwaves, the FCC has jurisdiction to require the BCO “for OUR democracy to function.”

So as this matter of right, **Cobble's lawsuit, 23-ci-6012 in Jefferson County Circuit Court**, demands the BCO that must apply FCC jurisdiction across the nation. **Here are the benefits of a BCO:** **1)** All broadcasters' coverage of all candidates so voters can learn & identify them on the ballots; **2)** transfers political influence to voters; **3)** diminishes corrosive dark money in politics; **4)** reduces the need for fundraising for more space & time for elected officials to function in Gov't that **5)** improves the efficiency of Gov't; **6)** minimizes the need for taxpayer-funded campaigns; **7)** no loss of ad \$revenues as broadcasters may advertise; **8)** develops “voter interest” in the election process and knowledge of Gov't; **9)** allows elected officials to share more time with their families that eases the stress of working in Gov't (for smoother operation of Gov't). ∅

Since 1933, Glass-Steagall had prevented derivatives and hedge funds traders, etc. from placing bank accounts & other consumer accounts at risk. Profits from these illicit trades are used to buy-up property (real estate, businesses, stocks & bonds, etc). As illustrated in **Attachment 3** (pg. 9, & pg. 1), **by 2022**, from records of the **Bank of International Standards**, traders have accumulated over **\$1.2 quadrillion** in derivatives contracts (a conservative estimate), and over \$100 trillion in hedge funds contracts from the labor and fortitude of the American people.

Violation 2: Reinstate competitive prime interest rate (propose 4.75%; it was 5.46% in booming 1999 economy). When taking office in January 2001, **in each quarter**, Pres. George W. Bush reduced the prime rate by 0.25%. By 2007, the prime rate was **0.25%** (near zero). This "too low rate" reduces economic activity & tax revenues because it chases dollars away from U.S. banks\communities in search of higher rates of \$returns. It discourages banks from lending to "retail consumers & small businesses" **the primary engine of the economy**. Instead, with such low rates, banks earn more from larger "corporate loans." – Here too, ending this cheap money will end Wall Street corporations running around buying-up property (real estate, businesses, stocks & bonds, etc) that drives up prices across the marketplace because it **decreases competition**. (For example, auto insurance keeps \$rising due to the consolidation of insurance companies.)

Violation 3: Stop the illegal Fed loans to investment bankers (Merrill Lynch, Berkshire Hathaway, Vanguard, Black Rock, Etc.). **On May 2, 2008**, then Fed Chairman Ben Bernanke announced that "investment bankers" could now borrow directly from the Fed (then at 0.25%) in violation of the **Federal Reserve Act of 1913 (FRA)**, Section 13, clause 2. Again, **for buying-up property**, every year this practice removes \$trillions from "commercial sector circulation" (the economy) for direct, illegal entry to the "financial sector" (Wall Street corporations). This practice also prevents "dollar monetization." To make-up for these economic losses / transfer of dollars, similar to "too low interest rates," we borrow more from the Fed that then forces constant tax & fee hikes and cutbacks on vital programs. This practice, too, has diminished the U.S. tax base leading ultimately to economic collapse.

UPDATE on Violation 2: In January 2022, the Federal Reserve began reversing the 0.25% "wholesale prime interest rate" to inoperably high rates. By 2024, it reached 8.5% with intent to collapse the economy to enforce outlawing cash. This is the "last straw" for tolerating the Fed, it's primary mission to destroy the prosperity of Americans.

Today, the *\$transfer-of-wealth* has produced the ocean-of-cash for where cheaper money is traded between companies without the Fed.

B. The Massive Tax Windfall

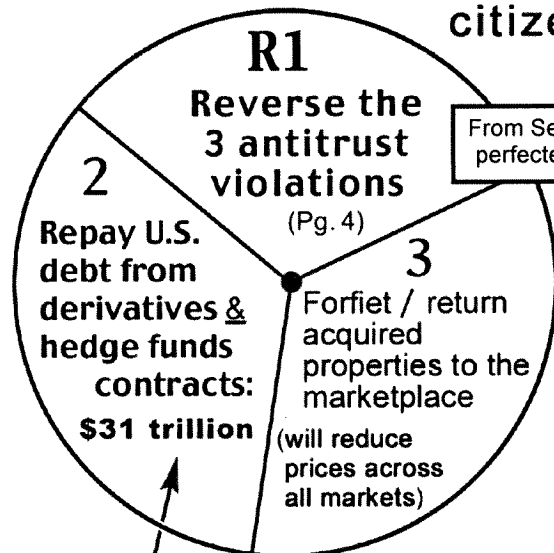
B-1. The **Restitution Schedule** in **Attachment 3** from the tort claim lists Restitution **R1** thru **R6** [for payment] to the American people.

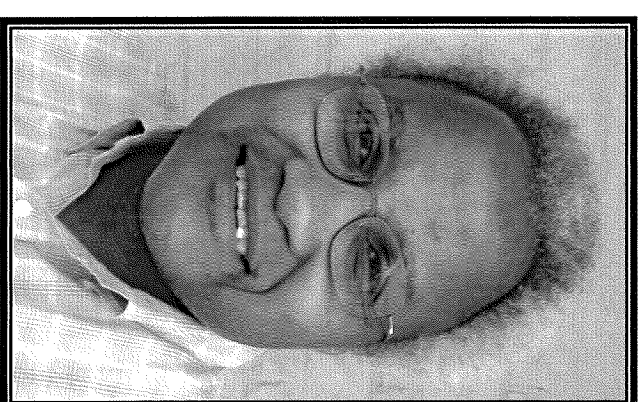

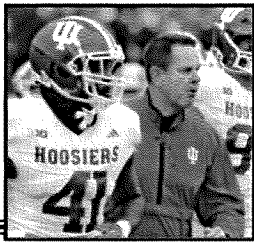
