Julia,

I hope all is well. My name is Jasmine Presley and I am the LA for Councilman Andrew Owen, District 9. We received a few calls regarding a neighborhood meeting "fiasco" last week as described by some of the neighbors. Please see the message below from one of our constituents:

"Several neighbors and I tried to attend a public meeting tonight at 100 N. Crestmoor that was listed in your last newsletter regarding a Conditional Use Permit. The owner told us that the meeting is actually tomorrow 1/26, and that only those he mailed "invites" to (adjacent property owners) are invited. That we shouldn't bother coming tomorrow because it's his private property and he won't let us in. I'm not sure what the purpose of the Neighborhood Meeting is when it is not attended by staff from the City to verify that it is held correctly and that accurate information is being presented, etc. He does not even seem to know what he's applying for.

He has tried unsuccessfully to develop his property recently so he is not well trusted in the neighborhood and we are all wary of his motivation this time around.

I am also contacting the case manager about this to try to straighten out the meeting information but just wanted to let you know."

I did not find the case manager's contact information on the notice linked below, so I was hoping that you could point me in the right direction or provide more information about the history of this property and the CUP application.

I appreciate your attention to this matter and look forward to hearing from you.
