## Special Discussion

**Budget Issues in Reimagining Public Safety - Amy Hess, Public Services; Vincent James, Community Building; and Kendall Boyd, Office of Equity.**

Daniel Frockt, Office of Management and Budget, gave a brief statement about this topic. He stated that the local general funds for the current Budget year for Louisville Metro Police Department ("LMPD") is about \$178 million, for Office of Safe and Healthy Neighborhoods is a little over \$1.1 million, and the Office of Equity is embedded within Human Resources.

Kendall Boyd, Office of Equity, spoke about resolving issues during the pandemic and in the wake of the death of Brianna Taylor. He spoke about the Build Back Better Together initiative having equity at its core. He spoke the Synergy project that addresses race issues and the need to train facilitators to help with the tough conversations that need to be had.

Chief Amy Hess, Public Safety, referenced the attached document about Louisville Violence Reduction Strategies. She spoke about needing many approaches and partnerships and the help of the community to reduce violence. She spoke about dependence on enforcement to solve problems and how it has led to inequities, and needing to provide other choices for people to detour them from going down the wrong path. She spoke about the Group Violence Intervention ("GVI") and Deflection models, and community outreach teams.

Vincent James, Community Building, spoke about why the violence is increasing in Louisville due to the pandemic and the need for a public health approach to violence prevention. He spoke about building a coordinated crisis system that partners with various community service agencies around the city. He also spoke about issues within the built environment.

The following was discussed:

- Hearing more in the future about the built environment issues
- Whether the issue is the disproportionate number of African Americans in jails compared to the population or who is committing the crime
- Partnering with Jefferson County Public Schools to help prevent crime
- The need to safely open the community centers and libraries and their

- closure being part of the problem
- Questions regarding trauma training, therapy, and mental health services being provided to public safety personnel when involved in a traumatic incident
- Whether the role of the Office of Safe and Healthy Neighborhoods is understood by the Council in regards to preventing versus reacting to violence
- Question about whether anyone is addressing the root issues amongst the Black population in Louisville, such as much higher rates of school suspensions, evictions, unemployment, etc.
- Question about LMPD's budget being over \$170 million and the low rate of solved homicides and shootings
- Information provided regarding the service levels being down and the population being up
- How long it will be before a noticeable decrease in shootings and homicides can be seen from the GVI initiative
- What is being done within LMPD to make the officers aware of LMPD's Homelessness Outreach Team
- Conversations being had regarding investing in Restorative Justice models
- Requiring cost-effectiveness determination in regards to how much it costs to incarcerate someone for particular petty crimes
- Addressing the root causes and not the symptoms
- 67 percent of the victims being Black
- Reasons for why funding was cut to particular programs, such as the programs not providing data to support their level of success and other administrative problems
- What needs to be done to fund anti-racism
- Louisville needing to provide adequate resources to invest in initiatives to see the outcomes, and not investing enough on the front end in regards to evaluation
- Questions about the Synergy program, who is being trained, and how it is being funded
- Acknowledging that there is a crisis and take some chances and investing in some programs to try to solve the problem rather than continuing to have conversations about it
- Investing in programs for longer periods of time to be able to more effectively evaluate them
- Administrative problems with the former Cure Violence Program but not the model it was based on
- Two areas in Louisville with large African American populations that do not have pools, and how quality of life is an important part of the conversation
- The Budget Committee will have a discussion about Budget issues in regards to quality of life on March 18
