Two (2) Speed Humps x \$2,215.00 = \$4,430.00
Two (2) Speed Hump signs x \$260.00 = \$520.00
Total = \$4,950.00

Please consider this letter as our official Statement of Cost for all speed hump related work. Each speed hump, including markings is \$2,215.00 and each sign is \$260.00. Based on our Engineering Studies, a total of two (2) speed humps and two (2) speed hump signs have been proposed for Blaze Way, between Bethany Lane and Floradora Drive. The total "not to exceed" cost is **\$4,950.00**.

As I understand it, your office will fund half the amount which totals **\$2,475.00** and your constituents have agreed to fund the remaining half, which totals **\$2,475.00**.

Upon funding approval, the speed humps will be installed as weather permits.

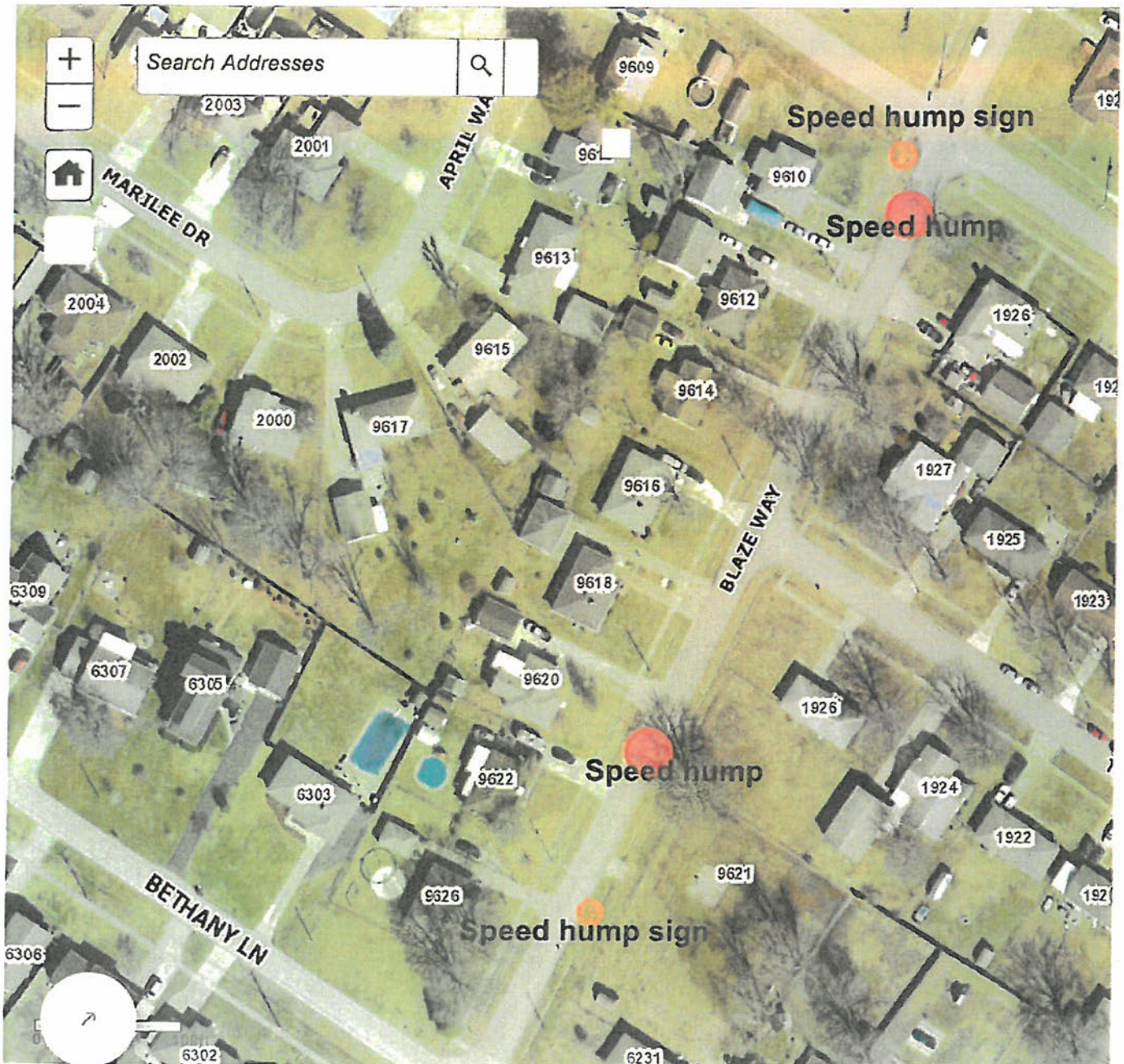

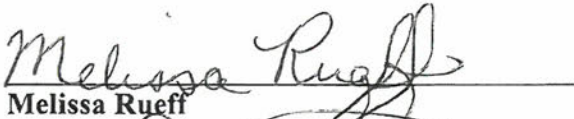

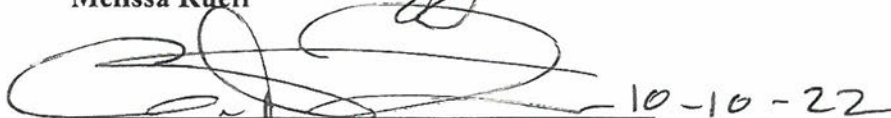
