### REQUEST

Street Name Change for all or portions of the following streets: Cedar Lane, Elm Drive, Evergreen Avenue, Lake Louisville Drive, Walnut Avenue, Wilson Avenue, Witlow Avenue and Woodland Avenue.

#### CASE SUMMARY/BACKGROUND/SITE CONTEXT

The streets in question are located with an area of Lake Louisvilla where the original record plat is being amended to create a new subdivision known as Park Springs. The area consists of a number of lots which were originally created by Record Plat Book 5, Pages 7 and 8. A vast majority of the lots were never developed, nor were many of the roads within the subdivision. Habitat for Humanity is in the process of developing a portion of the old Lake Louisvilla development. The proposed street name changes are for streets within this development (and beyond when the street names extend beyond the boundaries of the proposed development).

The following street name changes are being requested:

Cedar Lane	From its intersection with Lake Louisvilla Drive to its intersection with Walnut Avenue/Alley	Fawnlily Drive
Elm Drive	From its intersection with Lake Louisvilla Drive to its intersection with Witlow Avenue	Black Gum Lane
Evergreen Avenue	From its intersection with Lake Louisvilla Drive to its terminus south of Witlow Avenue	Possibility Way
Lake Louisville Drive	From its intersection with Lake Louisvilla Drive south to its terminus south of Elm Drive	Papaw Way
Walnut Avenue/Alley	From its Intersection with Lake Louisvilla Drive to its intersection with Witlow Avenue	Sweet Gum Lane
Wilson Avenue	From the county line north of Spring Drive south to its terminus south of Witlow Avenue	Ginkgo Trail
